Amendment Summary Form

Legislation: Fiscal Year ("FY") 2020 Budget Bill – Bill 36 (2019).

Proposer: Council Vice-Chair Keani Rawlins-Fernandez

Description: Add the following under "GENERAL BUDGET PROVISIONS," starting at page 41, in Bill 36 (2019):

"SECTION 25. **Definition.** As used in Resolution 19-100 and Appendix B of this ordinance, "Biodiesel Blend (other than B 100)" means mixtures containing 20 per cent up to 99 percent by volume of biodiesel with diesel or other fuels."

Reasons: This amendment implements the Council's intent to ensure Resolution 19-100, "ADOPTING THE FUEL TAX RATES FOR THE COUNTY OF MAUI, EFFECTIVE JULY 1, 2019," and the FY 2020 Budget Ordinance are consistent with Chapter 243, "Fuel Tax Law," Hawaii Revised Statutes.

FOR THE COUNTY OF MAUI,
EFFECTIVE JULY 1, 2019

BE IT RESOLVED by the Council of the County of Maui:

1. That, in accordance with Section 243-5 of the Hawaii Revised Statutes and Section 3.20.010 of the Maui County Code, the fuel tax rates, effective July 1, 2019, shall be set as follows:

HIGHWAY FUND

<u>Fuel Tax - Maui, Molokai, Lanai</u>	<u>Tax Rate Per Gallon</u>
Gasoline & Diesel Oil	\$0.230
Biodiesel (B100)	\$0.000
Biodiesel Blend (other than B100)	\$0.06
Ethanol	\$0.115
Methanol	\$0.115
Liquefied Petroleum Gas	\$0.115

2. That certified copies of this resolution be transmitted to the Mayor, County of Maui; the Director of Finance, County of Maui; and the Director of Taxation, State of Hawaii.

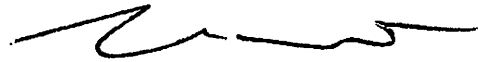
