### SUPPORTING THE NOMINATION OF CJ ELIZARES TO THE MAUI PLANNING COMMISSION

### 12 May 2025

Just as the Naulu rain suddenly appears at the end of a cloud bridge that straddles the uplands of Pu'u Mahoe to the southern end of Kaho'olawe, CJ Elizares would serve as a bridge to the Maui Planning Commision on matters involving Native Hawaiian traditional cultural practices and places. Appropriately, he serves as the Director of Naulu Farm in Honua'ula where he nurtures seedlings for reforestation efforts and cultivates native plants.

I will confine my testimony largely to Mr. Elizares' experience in and knowledge of Honua'ula, which qualify him for the cultural practitioner's seat. (He is also applying for the Upcountry seat.)

Mr. Elizares was four years old when he first traveled to Kaho'olawe on his Uncle's sampan. As a grown man, he has been a member of the PKO for 17 years, often in leadership positions. Among his responsibilities as a KUA is water safety for those traveling to the island. He continues to participate in and lead Ipu a Kane ceremonies. Most off all, Mr. Elizares has mana kupua, the ability to shape shift. If you ask him what this meant, he would probably say, "Go sit under the kukui tree."

Finally, Mr. Elizares would bring his knowledge of Native Hawaiian traditional and customary practices and the places where these practices occur, to the Maui Planning Commission's decision-making. He would bring balance and fairness to the decision-making, good judgment and reason. It would be as though Kamapua'a was spotted in the understory of a native forest.

I wholeheartedly recommend CJ Elizares' nomination for the Maui Planning Commission.

We are Olan Leimomi Fisher and Kevin Chang, Kua'āina Advocate and Executive Director, respectively, testifying on behalf of <u>Kua'āina Ulu 'Auamo (or KUA)</u>. "Kua'āina Ulu 'Auamo" stands for "grassroots growing through shared responsibility," and our acronym "KUA" means "backbone." **Our mission is to connect and empower communities to improve their quality of life through the collective care for their biocultural (natural and cultural) heritage, serving as a "backbone organization" that supports creative and <b>community-driven solutions to problems stemming from environmental degradation**. Hawai'i's biocultural resources continue to be negatively impacted by political, economic, and social changes, and the increasing dangers of climate change make fostering and empowering resilient communities acutely critical. We strongly support the nomination of Crichton Ka'uiki Lind to the Maui Planning Commission for the County of Maui through Resolution 25-108, and urge you to do the same.

Currently KUA supports three major networks of: (1) over 40 mālama 'āina (caring for our 'āina or "that which feeds") community groups collectively referred to as E Alu Pū (moving forward together); (2) over 60 loko i'a (fishpond aquaculture systems unique to Hawai'i) and wai 'ōpae (anchialine pool systems) sites in varying stages of restoration and development, with numerous caretakers, stakeholders, and volunteers known as the Hui Mālama Loko I'a ("caretakers of fishponds"); and (3) the Limu Hui made up of over 50 loea (traditional experts) and practitioners in all things "limu" or locally-grown "seaweed." **Our shared vision is to once again experience what our kūpuna (ancestors) referred to as 'ĀINA MOMONA – abundant and healthy ecological systems that sustain our community resilience and well-being.** 

We have worked with Ka'uiki for several years now, as he is an active member of our Lawai'a Pono Hui, an offshoot working group of our larger E Alu Pū network with a focus on policy issues for nearshore resources and communities. KUA has a long history with Ka'uiki's larger community in Kīpahulu, Maui, with our organization itself founded in part by kūpuna of Kīpahulu 'Ohana, Inc., including some of Ka'uiki's own 'ohana. We strongly supported the recent establishment of the Kīpahulu Community-Based Subsistence Fishing Area (CBSFA), as we have similar efforts to establish CBSFAs in places like Hā'ena, Mo'omomi, and Miloli'i through our networking and capacity building activities.

Ka'uiki and the rest of Kīpahulu 'Ohana were integral to the establishment of the Kīpahulu CBSFA. He currently serves as the CBSFA Makai Watch Coordinator and is also a member of the Kīpahulu and Kaupō Community Associations. It is undisputed that Ka'uiki holds extensive traditional knowledge of his home through his own kilo (observational science) and inherited knowledge through his deep ancestral ties to Maui as both a lawai'a (fisher) and mahi'ai (farmer) for kalo and other vegetables. We have also seen

Ka'uiki consistently display strong passion, dedication, and aloha for his beloved home on Maui and other communities across the pae'āina (Hawaiian Islands). We strongly believe in his ability to advocate for 'āina momona (abundance) in his community for future generations to love and enjoy. For all these reasons and more, Ka'uiki clearly possesses more than the required experience and background to effectively serve on the Maui Planning Commission.

The communities we work with are committed to ensuring the long-term health of our biocultural resources that they have cared for and depended on for generations since time immemorial. We believe our environment, the foundation of our very existence and "that which feeds" us all, requires long-term investment through a shared vision of achieving 'āina momona (abundance) once again. Getting there requires increased mālama 'āina (caring for our environment) leadership, awareness, and advocacy. This includes nominations for leaders like Ka'uiki Lind to the Maui Planning Commission. Our decisions today will continue to shape the future that our keiki's keiki will one day inherit – we hope for a future of shared and harmonious abundance, and hope you do, too.

Dear Chair U'u Hodgins and Members of the Government Relations, Ethics, and Transparency Committee of the Maui County Council:

I write in strong support of the selection of Christopher Jon ("CJ") Elizares to the Upcountry seat of the Maui Planning Commission, as well as in the capacity as a Native Hawaiian Cultural Practitioner, for a term expiring on March 31, 2030.

I have practiced in front of the Maui Planning Commission beginning in 1980 – when I participated in its first SMA contested case hearing - for a period of at least 40 years. During that time, I have had the opportunity to experience some Commissioners who I will never forget because of their dedication to protecting and preserving Maui's unique and irreplaceable resources and also Commissioners who were dedicated to protecting and preserving Native Hawaiian practices that were truly imperiled by proposed developments.

I already know that CJ Elizares would be one of those Commissioners. We need him on the Commission as Native Hawaiian Cultural Practitioner and in the Upcountry seat. He is wellqualified in both capacities. He will aide Commission decision-making in both capacities.

#### *Mr. Elizares is Well-Qualified to be Appointed to the Commission as Native Hawaiian Cultural Practitioner*

I am familiar with the subject matters that are within the decision-making jurisdiction of the Commission. I am also familiar with the duties of the Commission, imposed by the <u>Ka</u> <u>Pa'akai</u> case, to investigate the identity and scope of "valued cultural, historical, or natural resources" in a petition area, including the extent to which traditional and customary native Hawaiian rights are exercised in a petition area; the extent to which those resources—including traditional and customary native Hawaiian rights—will be affected or impaired by the proposed action; and then the duty to take any <u>feasible</u> action, to <u>reasonably</u> protect native Hawaiian rights if they are found to exist.

To assure the protection of these Native Hawaiian rights and practices, an Ordinance has been passed to assure that at least one member of the Commission has demonstrated expertise in native Hawaiian traditional and customary practices as evidenced by one or more of three credentials listed in MCC §2.28.070.A. 1-3. CJ clearly satisfies at least two of these three credentials: "2. Work history that demonstrates an appropriate level of knowledge in native Hawaiian traditional and customary practices, including traditional environmental practices." and "3. Substantial experience as a native Hawaiian traditional and customary practitioner."

Emails have been submitted to you by well-known and well-respected Native Hawaiian Cultural Practitioners, Kekuhi Kealiikanakaole and Davianna McGregor, clearly proving that CJ has demonstrated expertise in native Hawaiian traditional and customary practices and therefore undoubtedly qualifies for an appointment to the Commission as a Native Hawaiian Cultural Practitioner. He recognizes Native Hawaiian cultural practices, is a practitioner himself, and takes steps to protect and preserve these practices.

#### *Mr. Elizares is Well-Qualified to be Appointed to the Commission in the Upcountry Seat*

CJ is also well qualified to be appointed to the Upcountry seat of the Commission. I have known C.J Elizares for over five years. He is assuredly the sort of person who would fulfill his responsibilities to protect and preserve Maui's unique resources as an environmental steward, ensuring the availability of these resources for current and future generations. He is fair-minded. He is intelligent. He will take into consideration testimony received by the Commission and advocate for decisions consistent with the requirements of the law. At the same time, as a Native Hawaiian, he will assure that developments do not remove Native Hawaiians and allow for the perpetuation of Native Hawaiian practices.

In conclusion, I trust that you will support the selection of Christopher Jon Elizares to the Upcountry seat of the Maui Planning Commission, as well as in the capacity as a Native Hawaiian Cultural Practitioner.

#### 10 May 2025

To Chair U'u-Hodgins and Members of the Government Relations, Ethics, and Transparency Committee,

I am writing to offer my enthusiastic support for the nomination of Christopher Jon "CJ" Elizares to serve on the Maui Planning Commission in the Upcountry and Native Hawaiian Cultural Practitioner seats.

What follows is a more lengthy description of someone whose tremendous intellect and prolific stewardship are only surpassed by his integrity, and, a love and dedication to 'āina and his family.

#### Chapter 1: Stepping into arenas representing Maui, training the next generation

I first became aware of CJ while we were both student-athletes whose sports shared the gymnasium space at Kekaulike High School. CJ was a MIL Champion and top State finisher in wrestling. He would later coach wrestling for Kamehameha Schools and continue his competitive readiness by winning the Makahiki Games held at Hakioawa on Kaho'olawe. I mention these examples to highlight CJ's mind-body excellence, willingness to step into cultural and more mundane arenas, and commitment to legacy and training the next generation.

#### Chapter 2: A proven steward of ocean, land, and people

The next point at which I became aware of CJ was about a decade ago while on a Hawaiian Airlines flight, I came upon a video where CJ was speaking about the varietals of Hawai'i kō he was regenerating as lead farmer at Ocean Vodka. At this point in his life, CJ was heavily involved in Kaho'olawe and traditional openocean Hawaiian voyaging. A member of Hui o Wa'a Kaulua (HoWK), CJ earned the role of captain for HoWK. CJ and his team at Ocean Vodka planted sweet potato resulting in 400 pounds of nourishment to support a 2014 voyaging effort. CJ is quoted in a press release following that harvest, "we are stewards of ocean, and of land." What I hope to draw your attention to is CJ's proven leadership ability in open-ocean Hawaii voyaging and in cultivating Hawaiian foods - both of which speak to a deep understanding of not only our external environment - celestial movements, weather and seasonal patterns, soil regeneration, a love for Hawai'i food plants, but also an astute understanding of people dynamics. CJ is a proven steward of the ocean, land, and people.

#### Chapter 3: Continually called out of the ocean to nourish land and people

More recently, I have had the great good fortune to engage with CJ while I've been employed by Mākena Golf & Beach Club (MGBC). At this point, CJ had already spent time employed by the Kaho'olawe Island Reserve Commission as staff in their Cultural Department. MGBC was lucky enough to be granted the opportunity to travel to Kaho'olawe on a Protect Kaho'olawe 'Ohana (PKO) access in 2017. CJ conducted our orientation as a KUA for PKO and was lead zodiac captain for our travel to and from Kaho'olawe. CJ was and continues to be part of the PKO Ocean Safety crew with an adept understanding of the Honua'ula near-shore waters, 'Alalākeiki channel dynamics, and safely transporting people to and from Kanaloa moku. Our head Chef was on this access and so impressed by the food being grown by CJ and PKO at Hakioawa that we hoped CJ might become MGBC's Farm Manager. Again here, **the story continues of CJ being excellent in the ocean, but called out of the ocean to produce nourishment on land.** 

#### Chapter 4: Hō'ike: Actualizing what is Potential, An Applied Hawaiian Scientist

CJ would eventually agree to become Farm Manager at MGBC, transforming an old golf hole and tee box into what is now Nāulu Farm. The <u>www.makenainfo.com</u> website notes that "Nāulu Farm was designed to reflect and echo the movement of the largest and most life-giving elements in Makena: the seasonal and daily sun angles, and the wind current and cloud (thus rain potential) both called Nāulu." Pulling language from CJ's friends at Hui Ku Maoli Ola, CJ is able to transform land back into 'āina. **Nāulu Farm is an example of CJ's ability as an applied Hawaiian scientist to engage traditional place-based ecosystem knowledge so that land and people may thrive together.** 

**People, myself included, like to talk about the mutuality of land/people thriving together, CJ has shown his ability to actualize that potential**. MGBC is now able to have an 'Ōiwi Resources & Stewardship Department because CJ has the knowledge and skill to lead a team who are basically the DLNR for MGBC - caring for all natural and cultural resources at MGBC. None of this is possible without CJ's knowledge of the Honua'ula ecosystem, the history, archaeology, and culture of this area, and his unique ability to help revitalize not only ocean and land, but the people at the same time.

To hō'ike, to show or exhibit one's abilities in community and have experts in that particular area affirm one's growth in status (and thus responsibility) is a very Hawai'i practice. CJ has been appointed Kahu of the Nāulu ko'a, a rain shrine in 'Ulupalakua, by a preeminent Kumu on Maui. I have witnessed twice two additional Kahu anoint CJ as the next Kahu for their particular practices, one for heiau practices and another for spiritual care of the people and place of Honua'ula. CJ has been empowered by trusted Maui experts to hold the status of one who guards and cares for, who can make decisions for natural and cultural resources.

#### Chapter 5: Someone who can be trusted with power and decision-making

CJ is also incredibly smart. What I would come to notice in my own relationship with CJ is a unique fortitude as Geoge Helm reminds us, "do your homework," to be well informed, to read and be prepared to thoughtfully contribute. This will be helpful as a member of the Planning Commission. I think sometimes people may become intimidated by the range of CJ's skills, I hope you instead see his readiness to be a decision-maker as a member of the Planning Commission. CJ also spent time in construction and painting, is a qualified emergency responder and participated in first response during the Kula and Lahaina fires, and has been a sought out speaker on conservation and land stewardship over the last five plus years for the Conservation Conference, CTAHR, and recently winning recognition for his participation in the Ahupua'a Accelerator for a project on legacy building. What is the nexus of all these skills? To be honest, I think his abilities are beyond my own ability to articulate, but if you will allow me to try:

- Cultural protocol is safety protocol.
- I hope you see his depth of skill in ocean safety and first response as one expression of the range of safety protocols he understands as part of being a Hawaiian culturalist. He is also a lead for the Ipu a Kane ritual group and is trained and actively participates
- in repatriation efforts. These skills allow him to guard and protect our resources, land and people.

- Prolific because he has tremendous skills, but also the courage to take
- responsibility for these skills. A recent colleague of ours noted that CJ is
- prolific. CJ understands where there is potential for new life in an ecosystem and the process for how to bring that life into being. CJ also has the courage to step into leadership roles, to take responsibility for making actual what is potential. His hands
- and back show his commitment to being an applied Hawaiian scientist, and Honua'ula has a lot more native species coming back to life because of him.

As CJ's friend and work colleague, I find comfort and safety in his integrity and commitment to fairness and justice and that trusted Maui and Hawai'i cultural experts continue to appoint him to leadership roles. He loves Maui and Hawai'i culture, he is brilliant, he does the hard work and homework, and one of my favorite parts about him is he really loves and is dedicated to his children and his family. I am grateful to be alive at the same time he is. CJ has the character and skill that I hope you will empower to make decisions as part of the Maui Planning Commission and as the cultural seat.

I am writing to support the nomination of Christopher Jon "CJ" Elizares to represent the Upcountry/Native Hawaiian Cultural Practitioner seat on the Maui Planning Commission.

My name is Blake "Brutus" LaBenz and I have known CJ for over 15 years from our volunteer work as Kua (backbone) for the Protect Kaho'olawe 'Ohana (PKO). Kua are responsible for ensuring the safety, planning, logistics, and cultural protocols for public volunteer participants who come to Kaho'olawe. The PKO practices kilo (observations) of the environment and resources that affect the island; and in turn utilize these observations to increase our cultural understanding and sense of place. Such observations have helped to inform our deepened cultural ceremonial practices such as Makahiki and Ipu A Kāne rain ceremonies.

CJ is a leader and integral part of the Ipu A Kāne hui of practitioners who mālama rain koʻa (altars) on Maui and Kahoʻolawe to increase revegetation efforts on Kahoʻolawe. It has been observed that the Nāulu clouds and rains stem from Puʻu Māhoe on Maui and ceremonial chants and offerings are utilized to entice the rain waters to feed the island. As kahu of the Nāulu rain koʻa on Maui, CJ has been responsible for the physical, cultural, and spiritual integrity of the site and ceremonies since 2012.

CJ has also been a crucial component of the PKO's Ho'ōla 'Āina: Revegetation Hui who are dedicated to helping our native plants flourish. His expertise in landscape scale planning and understanding of the environment has been invaluable to the PKO. He has worked to ensure the proper working function of our water catchments, irrigation systems, and erosion control methods for the health of our native plantings. He is also spearheading the PKO's efforts to create a native ecosystem that will be used to support bringing the endangered Kapalupaluakanaloa back to Kaho'olawe.

As a farmer, he has been able to integrate customary cultivation methods with modern technologies to produce crops for both ceremonial and personal consumption. His knowledge of environmental resources and needs lends well to his incredible passion for growing native Hawaiian plant species. He is personally accountable for having planted thousands of native floras, but not just for the sake of planting them. As a hunter, he is astutely aware of the negative effects that invasive axis deer have had on the ecosystem. As such, I know that he takes great pride in cultivating species like wiliwili that have been so greatly impacted by the deer.

CJ's lifelong personal and professional experiences in the stewardship of both 'āina and kai resources stem from his 'ohana of fishermen and farmers. He prides himself on knowing his genealogy and understanding the environments that sustain him. I wholeheartedly support CJ's appointment to the Maui Planning Commission as someone who is grounded in cultural knowledge and practices, knowledgeable of Maui and its resources/environment, and who can thoughtfully consider social and community dynamics. I have no doubt that he will be able to approach issues from an aloha 'āina outlook, and always bearing in mind the decisions that would affect Maui's resources for generations to come.

Aloha

My name is Davianna Pōmaika'i McGregor and I am writing in support of the appointment of Christopher Jon "CJ" Elizares to serve on the Maui Planning Commission for the Upcountry and Native Hawaiian Cultural Practitioner seat. I have worked with CJ Elizares in the Protect Kaho'olawe 'Ohana for the past several years to restore the cultural and natural resources of the island, an ahupua'a of the Honua'ula Moku/District of Maui. The approach of the 'Ohana is to do consistent kilo, observations of the environment and its seasonal changes on the island and its natural resources, while also conducting traditional and customary ceremonies, such as the annual Makahiki to attract the seasonal rains of Lono, and working in coordination with the natural elements to install water catchments, tanks and irrigation lines to give life to native plantings.

Throughout the years of CJ's work with the Protect Kaho'olawe 'Ohana, he has demonstrated and applied both ancestral and researched Hawaiian environmental knowledge of Maui, Kaho'olawe and the surrounding ocean. He has engaged in Native Hawaiian traditional and customary practices on Kaho'olawe, including environmental practices with regard to erosion control measures, installing rain catchments and water tanks, irrigation lines and sustainingi native plants. Of particular note are his efforts to re-plant the endemic and endangered KapalupaluoKanaloa on the island, applying traditional Native Hawaiian methods to restore the native ecosystem on the island wherein the plant can flourish.

CJ has also played an important role in managing and sustaining the marine resources on the island, while allowing subsistence harvest for consumption by participants on huaka'i, cultural stewardship field trips, while on the island.

As a Native Hawaiian practitioner, CJ is also the steward for the Naulu rain ko'a/shrine to send the Kaleinaulu rain cloud to Kanaloa Kaho'olawe which the Protect Kaho'olawe 'Ohan constructed under the oversight of Kumu Hula Hokulani Holt. The rain ko'a is located on Ulupalakua Ranch lands near Pu'u Māhoe and its purpose is to attract the clouds that arise from the forests of Ulupalakua and send them across the channel to Kaho'olawe to water the native plantings.

Given my experience with CJ in the Protect Kaho'olawe 'Ohana, I believe that as a member of the Maui Planning Commission, CJ will review and deliberate upon proposals with the intelligence, heart and insights of a Native Hawaiian cultural practitioner with deep ancestral roots on Maui. He will examine the impacts of proposed actions from the perspective of the 'āina and its capacity to sustain new uses by present generations, while also reserving its resources for seven generations to come. He understands that the 'āina is precious and must be treated with respect, as a revered kupuna.

In closing, I respectfully support the appointment of Christopher Jon "CJ" Elizares to the Maui Planning Commission as someone whose culturally grounded ethics and outlook as a Native Hawaiian will provide an important voice for the 'āina in the deliberations of the Commission.
