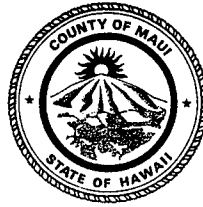

RELATING TO THE APPOINTMENT OF GERALD RABAINO TO THE LANAI PLANNING COMMISSION

WHEREAS, by correspondence dated February 9, 2018, Mayor Alan M. Arakawa notified the Council he nominated Gerald Rabaino to the Lanai Planning Commission for a term expiring on March 31, 2020, to fill a vacancy replacing Marlene Baltero, pursuant to Section 2.28.025, Maui County Code, and Sections 8-8.4 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and



1. That it approves the appointment of Gerald Rabaino to serve on the Lanai Planning Commission for a term expiring March 31, 2020;
