The Committee is also aware of other FY 2025 Budget adjustments for which Carryover/Savings may be used, such as the approximate \$2.3 million Johnson Controls, Inc. ("JCI") equipment

Pursuant to your letter dated August 14, 2024, regarding the subject matter, below are the responses to the following:

Section 3.97.040, Maui County Code, requires 20 percent of County Transient Accommodations Tax ('TAT") revenue to be deposited into the Managed Retreat Revolving Fund, except during Fiscal Years ("FY") 2025-2027. The Council appropriated \$12 million in the FY 2024 Budget for this mandated deposit based on estimated TAT revenue of \$60 million.

1. What was the actual amount of County TAT revenue collected in FY2024? How did that compare to the estimated revenue in 2024?

Response: Unaudited TAT collections in FY2024 amounted to \$69,622,435.21. This is an increase of \$9,622,435.21 over the estimated revenue of \$60,000,000 included in the FY2024 budget.

2. Did the \$12 million appropriation satisfy the Code mandate? If the answer is no, what adjustments does the Administration intend to propose?

Response: The Budget Office will provide a response to this question.

Section 3.100.040(C), Maui County Code, requires that 20 percent of all revenue generated by the General Excise Tax surcharge be used or projects that support the Department of Hawaiian Home Lands' homestead development. By Ordinance 5671, the Council appropriated \$5,767,148 to the General Excise Tax Fund – Department of Hawaiian Home Lands in the FY 2024 Budget for this mandated deposit based on estimated GET-surcharge revenue of \$28,835,741.

1. What was the actual amount of GET surcharge revenue collected in FY2024? How did that compare to the estimated revenue in 2024?

Response: Unaudited actual GET surcharge revenue collected in FY2024 amounted to \$34,498,300.04. This is an increase of \$5,662,559.04 over the estimated revenue of \$28,835,741 included in the FY2024 budget.

3. Did the \$5,767,148 appropriation satisfy the Code mandate? If the answer is no, what adjustments does the Administration intend to propose?

Response: The Budget Office will provide a response to this question.
