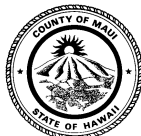

2. Would the Department consider making Lānaʻi its own division within the Department? Please explain why or why not.
3. Please provide an update on the Department's efforts to create a Summer PALS program on Lānaʻi.
