2. Please explain why the County Parks Special Revolving Fund has a \$0 balance as of June 30, 2024, and no anticipated revenues for FY 2025. What is the plan for this fund?

This fund was established in accordance with §13.04A.460 of the Maui County Code, which stipulates that any proceeds received by the department under Article VIII - Concessions, Sponsorships, and Donations must be directed into this fund. To date, there have been no proceeds meeting the criteria outlined in Article VIII for allocation to this fund.

Once funds are deposited into this account, the code mandates that all proceeds collected by the department under this article necessitate council approval for expenditure. These funds are designated for purposes related to the implementation of this chapter, including salaries, operational costs, equipment purchases, debt service payments, and County property maintenance.
