Wastewater is referencing Maui County Code 14.31.070 - Administration and Enforcement. "The Director is authorized to take any and all actions necessary to effect compliance with the provisions of this article." To be consistent with other Departments, such as the Department of Water Supply (DWS), Wastewater uses the same late fee of 1% per month as stated in the DWS, Maui County Administrative Rule, 16-7-4(b).

2. On page 8, under Fees - Landfill Disposal, there is a reference to the Department's ability to waive disposal charges for nonprofit organizations and organizations participating in a County-sponsored event under certain circumstances. Would you please provide the citation for the waiver so that it can be added to Appendix B?

Maui County Code 8.04.050 - Section E

3. Section 20.42.060, Maui County Code, authorizes penalties for violations of the sunscreen prohibition. Would you please advise if your Department imposes a set civil fine for a violation of this prohibition? Please explain.

EP&S currently doesn't impose fines; administrative enforcement is guided by Section 19.530.030, with no fines issued due to limited business violations. We determine sunscreen classification based on factors like active ingredients and marketing claims, ensuring compliance with relevant FDA regulations. However, we're developing administrative rules to address enforcement challenges, notably a specific business contesting our classification of "sunscreen" and our enforcement procedures. These administrative rules would outline enforcement and violation procedures, including the fees associated with violations."
