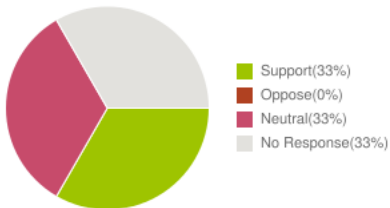

Overall Sentiment



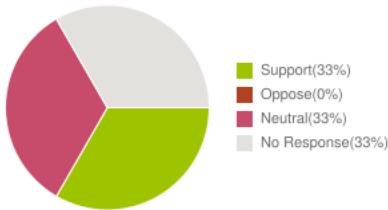

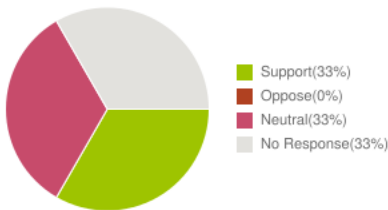
