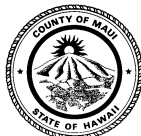

May I please request you identify any conditions, restrictions, deadlines, or other requirements the County must meet to receive full principal forgiveness. If there are, please provide:


1. Key dates or deadlines for encumbrance, construction, completion, payment, reporting, or closeout.

3. Circumstances under which the County could lose eligibility for full forgiveness or be required to repay part or all of the loan principal.
