- 2. That it disapproves the appointment of the persons listed in Exhibit "C" as members to East Maui Regional Community Board;
- 3. That the Council expresses its gratitude and appreciation to all applicants for their willingness to be considered for public service and actively participate in County government;
- 4. That it urges the Mayor to expeditiously fill the remaining seats on the East Maui Regional Community Board; and
