I am transmitting a proposed CD1 version of Bill 109 (2023), entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, APPENDIX A, PART I, OFFICE OF THE MAYOR."

The purpose of the revised bill is to amend the Fiscal Year ("FY") 2024 Budget, Appendix A, Part I, Office of the Mayor, by deleting projects for Maui Family Support Services, Inc. and County of Maui, Department of Fire and Public Safety; adding a project for County of Maui; increasing the total amount allocated to the program by \$1,478,750; and deleting the overall appropriation for the program and appropriating the funds by project.

The proposed changes are as follows:

- Remove the appropriation for CDBG-Coronavirus Program
- Under Community Development Block Grant (CDBG) Program, remove the overall program appropriation and appropriate the funds by project.

In reviewing the original appropriation for the Coronavirus Program funds, no specific recipients or projects were listed and is not necessary to re-program the funds through a budget amendment as they were already acknowledged in a previous Fiscal Year budget.

The overall program appropriation has been deleted and the funds have been appropriated by project to make it clear that none of the re-programmed funding will be used for CDBG Program Administration. This amount remains the same as the amount approved in Resolution 23-108 on April 11, 2023.
