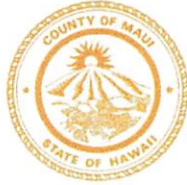

The purpose of the proposed bill is to amend the Fiscal Year 2026 Budget, Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2026, Department of the Prosecuting Attorney, Edward Byrne Memorial Justice Assistance Grant Program to insert conditional language for 0.9 LTA equivalent personnel.
