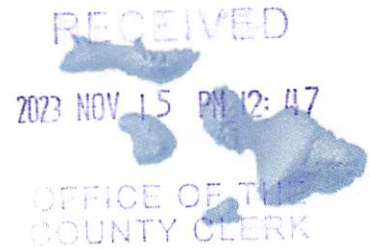

**SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2024 BUDGET  
(REVENUES; DEPARTMENT OF FIRE AND PUBLIC  
SAFETY, FIRE/RESCUE OPERATIONS PROGRAM)**

On behalf of the Department of Fire and Public Safety, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, REVENUES; AND DEPARTMENT OF FIRE AND PUBLIC SAFETY, FIRE/RESCUE OPERATIONS PROGRAM."

The purpose of the proposed bill is to 1) increase Carryover/Savings in the General Fund and Total estimated Revenues by \$2,000,000; and 2) amend Department of Fire and Public Safety, Fire/Rescue Operations Program by increasing the appropriation for Category B – Operations & Equipment and the total appropriation in the amount of \$2,000,000 and adjusting the Operating and Total Appropriations accordingly.

These funds will be used for operations and equipment costs related to wildfire recovery including refueling of generators, water trucks, water tanker and dozer services, Air 1 flights, and costs to replace Engine 1 and Wildland 3 which were destroyed during the fires. The County of Maui will initially need to pay 100 percent of the costs for the replacement of Engine 1 and Wildland 3, but will be recovering a portion of the costs through insurance and the Federal Emergency Management Agency. The requests for these payments are still pending.

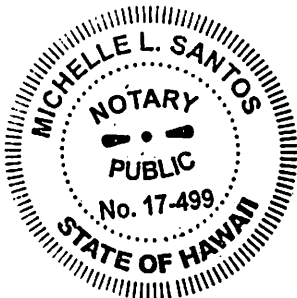



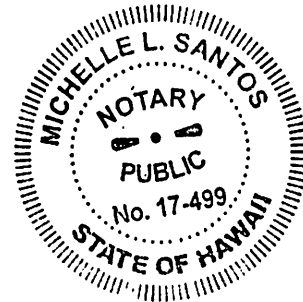
