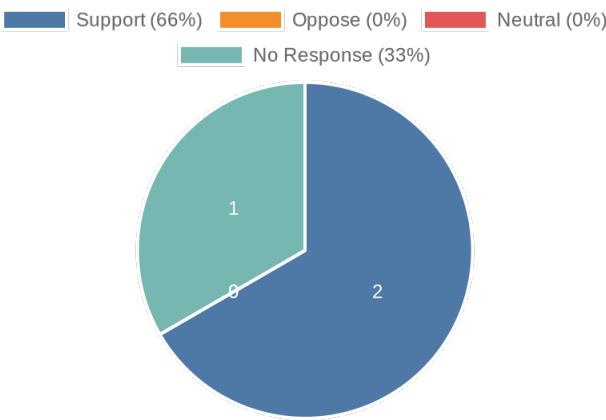

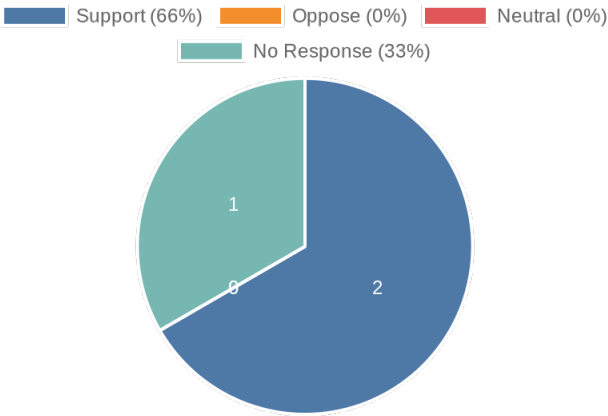

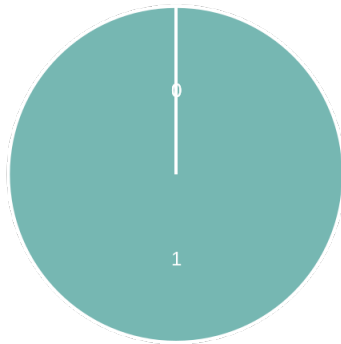
Overall Sentiment

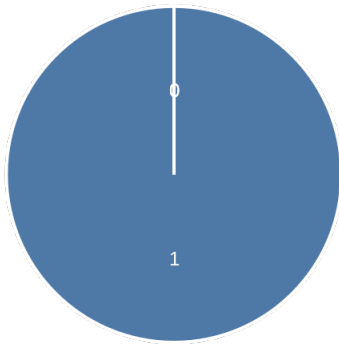

I am in support of this Plan, as the goals, objectives and actions in it reflect our greatest food and nutrition security needs in Maui County. During community-led listening sessions, which happened in my hometown of H_na and many other communities across Maui Nui, residents in each place were called to come together and provide their mana_o on the items that should be prioritized in this Plan. 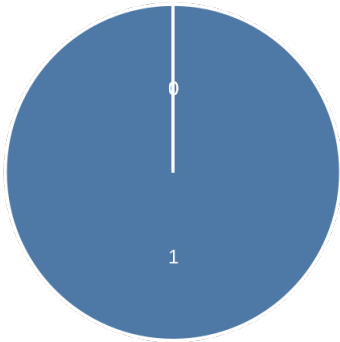
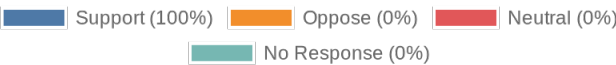

Dear Chair Lee and Honorable Council Members,

As former Committee Chair on Agriculture & Food Systems, I write in strong support of Agenda Item HCR 42—a House Concurrent Resolution encouraging each county in Hawaii, including Maui, to establish its own biosecurity plan tailored to local needs

Invasive species continue to pose urgent threats: degrading native habitats, endangering endemic species, and jeopardizing agricultural livelihoods and public health. HCR 42 responds by encouraging localized biosecurity planning—empowering each county to develop proactive, community-based strategies for early detection, rapid response, and invasive species mitigation.

Maui County's leadership in adopting a customized biosecurity plan will strengthen statewide coordination, support innovative and culturally appropriate strategies, and safeguard Maui's unique ecosystems and agricultural resilience. Through inter-county collaboration and partnership with the Department of Agriculture and Biosecurity and the Hawaii Invasive Species Council, Maui can help shape a comprehensive, island-sensitive biosecurity model.

Mahalo for your consideration. I wholeheartedly support Maui County's engagement with HCR 42 and stand ready to assist in bringing this vision to fruition.
