A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, DEPARTMENT OF FINANCE, COUNTYWIDE COSTS, INCREASE THE CONDITIONAL LANGUAGE APPROPRIATION UNDER INSURANCE PROGRAMS AND SELF INSURANCE IN THE AMOUNT OF \$400,000

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:


SECTION 1. Ordinance 5816, as amended, "Fiscal Year 2026 Budget," Section 3.B.6.g.(7).(i), is amended to increase the conditional language appropriation for the negotiated amount for temporary hazard pay for eligible Maui County Hawaii Fire Fighters Association in the amount of \$400,000, to read as follows:

SECTION 3. This Ordinance takes effect on approval.




