Dear Chair Cook:

The Department of Housing is in receipt of your letter dated July 18, 2024, requesting information on improving the County's building permit review process. The Department's response is provided below.

 Please provide a summary of your Department's discussions, proposed plans and modifications, and a potential timeline for expediting the permitting process.

The Department operates with a two-business day turnaround time on both standard and fast-track permit applications, and generally completes its review in less than one business day. Given this turnaround time, the Department does not have additional recommendations on how to expedite its permit review process.

- 2. Section 2.96.160, Maui County Code, establishes fast-track permitting for qualified residential workforce housing projects.
  - a. How many projects have qualified under this fast-track permitting process?

Following former Mayor Arakawa's directive on fast track permitting for workforce housing projects, dated April 29, 2018, which was transmitted to all County departments on June 21, 2018, there have been 18 qualified projects as follows:

b. How could this section be amended to improve efficiencies in processing permits?

As required by Section 2.96.160, Maui County Code, the Department reviews permit applications within two-business days. Given the Department's turnaround time, it does not have additional recommendations on how to expedite its permit review process.

However, the Department notes that under Section 2.96.030(A)(1), Maui County Code, residential developments of "Ten or more lots," are subject to Chapter 2.96. Under the Building Permit Application Routing Schedule, all residential building permit applications are routed to the Department for review regardless of whether the associated subdivision includes ten or more lots. Residential subdivisions with nine or fewer lots do not trigger the requirements of Chapter 2.96, and therefore do not need to be forwarded to the Department for review.
