SUBJECT: COUNTY PERMIT PROCESSING EFFICIENCIES (WAI-1(16))

The Department is in receipt of your letter dated June 13, 2024 requesting information as it relates to permit applications for residential, single-family dwellings. The Department's response is provided below.

- 1. The Department's standard process for review of residential, single family dwellings building permits is as follows:
 - a. The Development Services Administration (DSA) notifies the Housing Division via email when applications have been received. Staff reviews applications on MAPPS (building plans, address, site plan, subdivision, etc.). The permit application is further evaluated to check whether provisions in Chapter 2.96, Maui County Code (MCC), apply and if a Residential Workforce Housing agreement (RWHA) is needed.
 - If the property does not require a RWHA, it is approved (Not applicable).
 - If the property is developed as a Workforce Housing project, staff confirms the RWHA has been completed and notes that on the approval for the application.

- b. The Development Project Coordinator in the Housing Division reviews all permits for the Department in accordance to process noted above.
- c. The Department reviews the permit applications to determine if the project triggers Chapter 2.96 MCC, and requires a RWHA.
- d. The Department's review is based on applicability as stated in Chapter 2.96, MCC. Permit applications are reviewed and approved or disapproved within two business days.
- 2. The Department does not use an internal checklist.
