THE REGULAR MEETING OF THE COUNCIL OF THE COUNTY OF MAUI, STATE OF HAWAII, WAS HELD IN THE COUNCIL CHAMBER, KALANA O MAUI BUILDING. WAILUKU, HAWAII, ON FRIDAY, JANUARY 20, 2017, BEGINNING AT 9:02 A.M., WITH CHAIR MICHAEL B. WHITE PRESIDING.

CHAIR WHITE: Will this meeting of the County of Maui Council please come to order.

Mr. Clerk, please call the roll.

DEPUTY COUNTY CLERK JOSIAH NISHITA: Mr. Chair, there are eight Members present and one Member excused. A quorum is present to conduct the business of the Council.

CHAIR WHITE: Thank you, Mr. Clerk.

We have opening remarks this morning from Vice-Chair Carroll.

OPENING REMARKS

The opening remarks were offered by Vice-Chair Robert Carroll.

CHAIR WHITE: Thank you very much for those thoughts, Mr. Carroll.

Members, will you all please rise and join me in the Pledge of Allegiance.

PLEDGE OF ALLEGIANCE

The Members of the Council, and others in attendance, rose and recited the Pledge of Allegiance.

CHAIR WHITE: And before we proceed, if everyone can please put their phones on silent mode.

Mr. Clerk, let's proceed with the agenda.

DEPUTY COUNTY CLERK: Mr. Chair, proceeding with the presentation of testimony on agenda items. We have established limited interactive communication that enables individuals from Hana, Lanai, and Molokai, to provide testimony from our District Offices.

Individuals there who wish to offer testimony from Hana, Lanai, and Molokai should now sign up with District Office staff. Individuals who wish to offer testimony in the chamber, please sign up at the desk located in the eighth floor lobby just outside the chamber door. Testimony at all locations is limited to the items listed on today's agenda.

When testifying, please state your name and the name of any organization you represent.

Currently we have no testifiers at our District Offices.

The first person to testify in the chamber is Jonathan Starr, testifying on County Communications 17-51. He will be followed by Helen Nielsen.

PRESENTATION OF WRITTEN OR ORAL TESTIMONY

MR. JONATHAN STARR (testifying on County Communication No. 17-51):

Good morning, Councilmembers and staff. I want to thank you for your service and express appreciation. My name is Jonathan Starr, I live in the beautiful and harmonious community of Kaupo, East Maui and also part-time in Wailuku, and I am a board member of the Wailuku Community Association.

It's really nice to be here, I see a room full of people who are really dedicated with good hearts, and willing to spend everything they have in their life to do good deeds. So I'm sure that really good things will happen this term and I thank you for your service.

I am here representing the Wailuku Community Association on County Communication 17-51. I know it's a little preliminary with this, but to a lot of us who are concerned about the safety and the usefulness of our roads and byways, that intersection by Pomaikai School on Maui Lani Parkway is a terrible example of a road that's unsafe, it's in proximity to a school and parks and every traffic transaction is an accident waiting to happen.

When it was first built, first Dan Burden and Mark Fenton, two grade experts on how to make roads safe for everyone came over. And I had the opportunity to bring them over there, they tend to stay with me and I get to get a free lesson in, in, in road technology and multimodal. And both of them felt that that's a perfect location for a roundabout. It would be safe, it would allow more traffic to flow cause although it, you know, it doesn't stop with a light, it flows slowly and steadily in a cross where people, children, bicycles cross in a very narrow portion where the traffic is moving slowly. They're really taken over in many places and that would be a perfect, a perfect opportunity to have a larger one to match the two smaller ones we have on Maui.

I was talking with the Kauai Mayor at the Leg. the other day, and he has become such a fan of roundabouts and the Kauai community is just demanding wherever they're suitable that they are put in. So please refer this to the right committee and look forward to a really good discussion on it and are built environment in the future and mahalo for being here. Thank you.

CHAIR WHITE: Thank you very much, Mr. Starr. And thank you for your interest in the project.

COUNCILMEMBER SUGIMURA: Chair.

CHAIR WHITE: Yes, Ms. Sugimura.

COUNCILMEMBER SUGIMURA: Thank you. Jonathan, I know that you are such an avid biker also, so I'm just curious to see from that prospective, I know traffic-wise and for children's safety, I can see that, but what about biking for roundabouts, what is your experience?

MR. STARR: It's really much easier to get through a roundabout on a bicycle. You know, both people like me who, I'm not an avid sports bicyclist, I don't wear spandex, and I don't ride fast, but I do ride regularly. Where you have to cross a traffic lane you only crossing eight foot and it's at a point where you can see the cars and the cars can see you, so it's really safe, whereas, you know, signalized intersections are a lot hairier. It works good for bikes, it works good for pedestrians, it works good. I had a hip replacement a few years ago, I could barely get across a wide intersection or a fast intersection. I could get across roundabouts just fine.

COUNCILMEMBER SUGIMURA: Thank you.

CHAIR WHITE: Interesting. Any other need for clarification?

COUNCILMEMBER KING: I have a question.

CHAIR WHITE: Ms. King.

COUNCILMEMBER KING: Yes. Thanks, Jonathan, I'm a big fan of roundabouts too, and I think I live in the only area that actually has a short roundabout and it's great.

My question was that have you brought this up with the MPO committees, the technical committee would be a good place to, I think insert this information and get support.

MR. STARR: I will. I lobbied very hard to bring the MPO here, I worked with Ford Fuchigami to try to expedite it and once they formed, I kind of dropped the ball and haven't been to a meeting, but I will.

COUNCILMEMBER KING: Just to bring that up and then also maybe look for ways that we might be able to do public/private partnership and lower the cost of that, of the insertion of, you know, a roundabout, cause I believe I was told it was about eight million dollars to put the one in Kihei in, so.

MR. STARR: Yeah, the one in Kihei is kind of a showpiece and first one, it was maybe a little bit overdone with the plantings, which are gorgeous.

COUNCILMEMBER KING: Right.

MR. STARR: But I know that the cost if you take a ten year, look at what the cost is, it's quite a bit less than a signalized intersection. Cause the maintenance is, you know, just a little bit of landscape maintenance and feed it a bit, add water.

COUNCILMEMBER KING: I think you're right, the problem is that there is already a light there, so we're not talking about, you know, instead of a light, we have to actually replace it. So that's, I just wanted to kind of put that bug in your ear and maybe start thinking about it in terms of how we can get the community behind it and to help out with that.

MR. STARR: Um.

COUNCILMEMBER KING: Cause we're so short on funds for the MPR.

MR. STARR: I can ask around, but I really do believe that it's, it's a cost saver if we're not looking at just an immediate expenditure, but taking the maintenance into account. But you know, maybe there's a way and I'll help look for it.

COUNCILMEMBER KING: Thank you.

CHAIR WHITE: Mr. Guzman.

COUNCILMEMBER GUZMAN: Thank you, Chair. I'm not sure whether you are aware, and that's the question. That the, we actually, Public Works has proposed the roundabout. They did the analysis as to whether the roundabout versus the traffic signaling, what were comparable in terms of the budget financial situation and it was basically equal. So, they are moving forward with that, we've actually had meetings with Pomaikai School and their administration because some of the issues were, were the children be able to cross the roundabout, so that's on progressively, you know, getting started and moving forward. So uh, I'm not sure if you are aware of that. Were you aware of that?

MR. STARR: I, yes, I was watching it happening and I, it takes a shift. As Kauai Mayor expressed to me the other day in Honolulu, it's a learning curve and it's a cultural shift, you know, people slowly get used to it and then they have trouble, they realize how difficult it is dealing with signalized intersections with fast traffic flow. So um, you know, there is one place where the County is really moving in a good direction and we'll continue to support it.

COUNCILMEMBER ATAY: Chair?

CHAIR WHITE: Yes, Mr. Atay.

COUNCILMEMBER ATAY: Thank you. Thank you, Jonathan for bringing this to attention. I was just at the same intersection last evening. Aside from having a school right there, just up the road is also our new regional park with all of the sports activities, that's a main intersection that everyone, you know, so there's hundreds of cars when the sporting events come out, so I think I would agree with you, roundabout is necessary there.

MR. STARR: I just want to speak to that place because I chair the Maui Planning Commission when we heard the VMX the first time, well before it was built and the site inspections. And we were shown a beautifully landscaped wide pedestrian and bicycle and, you know, even a skateboard friendly kind of meandering pathway from the school side all the way up to the commercial.

COUNCILMEMBER ATAY: Right.

MR. STARR: Separate from the road. And on that basis, there were no bike lanes on the Maui Lani Parkway and there was not a sidewalk on the second side of the parkway, because the commitment was initially to build this path, that was going to be a major feature and that never happened. Part of it was the DOE refused to allow it to access directly into the school. You know, that was a time when DOE was feeling that schools need to be, you know, surrounded by chain link and barbwire and so kids can only go out where all the traffic is, which is dangerous. I mean that's where most of the accidents happen for children is right in front of schools. So, I don't know if that's still in the design to take the bicycle and pedestrian traffic away from the road or not, but it was there when we passed it and it was a condition of the original approval.

CHAIR WHITE: Thank you very much, Mr. Starr.

Mr. Clerk.

DEPUTY COUNTY CLERK: The next person to testify is Helen Nielsen, testifying on County Communication 17-51. She is the last individual who signed up to testify.

MS. HELEN NIELSEN (testifying on County Communication No. 17-51):

Good morning, Chair. Good morning, Councilmembers. Happy New Year to you all. I'm also here to testify on behalf of the roundabout, although it may be moving along as Councilmember Guzman mentioned.

I just wanted to mention that the National Transportation Administration website talks about roundabouts, and they talk about both efficiency and safety. And that's exactly what this intersection needs, is efficiency for the cars and safety for the kids. It also talks about the challenges of introducing roundabouts to communities, because like Jonathan said, it's a cultural shift. People just don't know and a lot of people are adamantly against it, but that website also talks about how to educate the community about the safety features of roundabouts.

So I would like to encourage more, when I was a kid, I was hit by a car near an intersection at the age of three. I would not wish that on any child or any family, so this is a personal thing for me in a sense. That whole area is going to develop with so many more kids. Like Councilmember Atay had mentioned, that whole regional park will be there, there is a lot more homes going up and really, that's the only intersection right now to get through that area. So I really appreciate your forward thinking and thanks for your time this morning.

CHAIR WHITE: Thank you, Ms. Nielsen. Members any need for clarification. Seeing none, thank you for being here this morning.

MS. NIELSEN: Thank you.

CHAIR WHITE: Mr. Clerk.

DEPUTY COUNTY CLERK: The next person to testify is Rosemary Robbins, testifying on County Communications 17-60, 17-37, 17-30, 31, and 32. She is the last individual who has signed up to testify in the County Chamber.

MS. ROSEMARY ROBBINS (testifying on County Communication Nos. 17-30, 17-31, 17-32, 17-37 and 17-60):

They are all related, don't worry. I'm hearing this about, in schools, and having been an educator for over fifty years, history going back here in Hawaii. We are now hearing about on the national level, people having guns in school to protect the kids in school. So, as time goes on, some of those are solutions that come about, some of those are additional problems. I probably couldn't hit the broad side of a barn with a gun, and to think I might be responsible for people in a classroom is pretty scary and I speak not only for myself on that one.

But today, starting out with County Communication No. 17-60. Okay, and this is a Memorandum of Agreement between the Board of Water Supply, Maui and

Department of Water, County on Kauai. And it says on here that although the migration of being just responsible ourselves and dealing with the Island of Oahu, City and County, this change was necessitated by actions of the Hawaii Board of Supply. But I got the material and read all through it and nowhere does it say what that behavior was on part of the Honolulu Board of Supply that would mean that we need to not to continue just with partnership with them, but to have a sole partnership with Kauai.

Kauai, remember about the deaths that they had up there seven years ago makes me hopeful that all of the paperwork from the spill wells has been cleared up. There were people found guilty and there were years and years of delay in rectifying those problems, so let's hope that would have been helpful to have us now be involved with an outfit that has been through the tough parts and want to get on with the better.

This ends up today with saying that the Department of Water Supply, right here on Maui, respectfully request that this matter be referred to the appropriate Council committee for expeditious review. It would be hopeful that today we will hear what committee here in Maui, that was before it got to the Council itself.

Okay and then over onto item 17-37 on today's agenda that's coming from the Budget Director. Still not here today, I hope he's okay. And it talks about the County Council budget that was referred by the Administration and is up to ultimately to yourselves in terms of putting that through and affirming that. I read, got the material, read through all of this and there is some conflicting, perhaps identification as to who the Water Director was, the one that we've known for years and the one that's now signing papers. I couldn't find anything that said when that came about, so I don't have that information, that may be helpful for people to hear from you folks too. In dealing with this one, it's like the rest of life, there's good news and bad news. I'd like to draw to our attention and the fact that we have so few people here today, like zero in the gallery right now, and eight of nine of our Councilmembers, that's good news for us, like I say, I hope that the missing person in the Council is okay.

The issues that are coming up on this are about acquiring Wailuku Water Company and the reasons for that happening are reasons that were brought up more than fifteen years ago, when a group of concerned citizens, all volunteers not on anybody's payroll, were responsive to articles in the Maui News saying that there needed to be an address of Upcountry water problems. People were getting sick, people have since died, but some of those at least stand a better than fifty percent chance of having survived, but not well and not through with their original, the actuarial statistics would have been for their life span.

So we need to make sure that those in the 17-30, 31 and 32 are in alignment with what was covered by the County recruited at that time, boil report, which said that the

Department of Water Supply was very fragmented. One division didn't know what the other division was doing, they were understaffed, are we not hearing that still now but only recently, but the good news is we are hearing it.

So the water testing results at that time, and we were working with the, keeping in mind now you've got Federal, State and County levels of government and we were working with U.S. Senator--

CHAIR WHITE: Ms. Robbins, could you wrap up your testimony on that item and move to the next item please.

MS. ROBBINS: I just did. I'm sorry. Talking about what was then, what's now and what's in the items that are on today's agenda, that we just spoke about, I just spoke about.

With Dan Inouye, may he rest in peace, and it was that there were problems brought up that were not addressed at the time. They have exacerbated, gotten worse and now we're ending up with being asked to fund an inquiry about spending \$150,000 to see what's definitely just the tip of the iceberg. Cause when you go down those other numbers that we mentioned, the 17-30, 31, and 32, they are talking about problems that were identified all those years ago.

And including, we had the man global expert from Virginia Tech, talked to Marc Edwards. All those records are here somewhere, all of those Upcountry oversite advisory committee meetings were recorded. There are audio/video discs that exist somewhere here in the County, which is where we did our operations. So I am certainly aware that's the tip of the iceberg, but it's an iceberg too big to miss in terms of finding those records and in terms of addressing them. This might be a very good thing, dealing with the, what used to be--

DEPUTY COUNTY CLERK: Five minutes.

MS. ROBBINS: --sugar, and is now water. So let's make sure that we don't continue to perpetrate any of the problems that we do by way of omission or commission and move on. This is certainly not something that's ready for immediate resolution today after more than fifteen years. It's like that hurry up and wait thing you hear about sometimes.

So, thank you.

CHAIR WHITE: Thank you, Ms. Robbins. Members, any need for clarification?

COUNCILMEMBER ATAY: Chair.

COUNCILMEMBER KING: Yeah, I just, point of order. This is a communication that's being sent to committee, not a resolution that we are voting on today?

CHAIR WHITE: Correct. Everything is up for further review later

COUNCILMEMBER KING: Okay, just wanted to clarify that.

CHAIR WHITE: Mr. Atay.

COUNCILMEMBER ATAY: Thank you, Ms. Robbins.

MS. ROBBINS: You're welcome.

COUNCILMEMBER ATAY: Can you clarify for me the name of the Virginia Tech Professor?

MS. ROBBINS: Yes, Dr. Marc Edwards. He was the one that just did all the exposure up in Flint. I mean he's globally known.

COUNCILMEMBER ATAY: Did you have a guesstimate year of when this study was shared?

MS. ROBBINS: Which one?

COUNCILMEMBER ATAY: We could probably go to the archives.

MS. ROBBINS: The one from here?

COUNCILMEMBER ATAY: Yeah.

MS. ROBBINS: Well it got blocked before all of the money. We got some money through Dan Inouye, from the Feds, and we never got a good explanation of where all that money was spent and now as we're reading through on what's going to be examined here, we're talking about renovating, collecting of stuff.

COUNCILMEMBER ATAY: Yeah, I just want to try to kind of get close to the year that you think this was, so that I can go back into the archives and check that out.

MS. ROBBINS: Thank you for your trust in doing that, yes, it was the early 2000's when we were meeting, so the problem was escalating prior to that.

COUNCILMEMBER ATAY: Okay. Thank you.

MS. ROBBINS: Uh-huh.

CHAIR WHITE: Anything further Members? Seeing none. Thank you for being here this morning.

MS. ROBBINS: You're welcome.

CHAIR WHITE: Mr. Clerk.

Bill 122 amends the Fiscal Year 2017 Budget, Appendix A, Part I, Grant Revenue by increasing the grant for the Civil Defense Agency, State Homeland Security Grant (SHSG) Program by \$90,000. The grant award is from the State of Hawaii, Department of Defense for a total amount of \$589,800. These funds may be used to fund the following core capabilities and investments: (1) cybersecurity; (2) community resilience; (3) threat and hazards identification; (4) environmental response for health and safety; (5) mass search and rescue; and (6) responder health and safety.

Bill 123 amends the Fiscal Year 2017 Budget, Appendix A, Part I, Grant Revenue by adding a new grant for the Department of Housing and Human Concerns, entitled Kaiser Foundation Health Plan, in the amount of \$7,500. The funds supported the 15th Annual Maui Family Caregivers Conference held on November 18, 2016.

Bills 124 and 125 amend the Fiscal Year 2017 Budget as it relates to building renovations for 2154 Kaohu Street. Bill 124 adds an appropriation of \$50,000 for air conditioning, electrical improvements and related permitting cost for one of two buildings on the property. The building will be occupied by the MPO staff, CDBG staff, and others if space allows.

Bill 125 amends Appendix C of the Fiscal Year 2017 Budget by adding the appropriation and a description of the project.

Members, I respectfully ask for your support of all of these Bills. Thank you.

The proposed bill establishes a fund for the deposit of all proceeds from the parking concession located on the property under the control and management of the County, on the area identified as Tax Map Key (2) 4-6-007:036 in Lahaina, Maui, Hawaii.

The fund shall be used for the preservation and restoration of Hawaiian historic and cultural artifacts and the sites in the County, including the Mokuhinia Ecosystem Restoration Project.

The restoration on the site has been ongoing since 2013. The Cultural Surveys Hawaii, Inc. is currently performing an archaeological inventory survey. The restoration work is planned to be accomplished in phases, with phase one commencing upon approval of the survey.

CHAIR WHITE: Thank you, Mr. Clerk.

Mr. Carroll.

VICE-CHAIR CARROLL: Thank you, Chair.

I MOVE TO WAIVE THE REQUIREMENTS OF COMMITTEE REFERRAL AND RECOMMENDATION PURSUANT TO RULE 7(E), OF THE RULES OF THE COUNCIL.

COUNCILMEMBER CRIVELLO:

SECOND.

CHAIR WHITE: We have a motion from Mr. Carroll and a second from Ms. Crivello.

Mr. Carroll.

VICE-CHAIR CARROLL: Thank you, Chair.

Passage of Bill 1 (2017), Draft 1, requires the Council to set the salary of the Director of Council Services by resolution.

CHAIR WHITE: Thank you.

Members, any further discussion on the waiver?

COUNCILMEMBER KING: Mr. Chair.

CHAIR WHITE: Yes, Ms. King.

COUNCILMEMBER KING: Yes, I speak against this waiver, due only to the fact that some of us on this Council were, have not been, were not aware of this. It creates a new position, and I think that hasn't been made obvious, or the reason for the new position. I'd like to be able to look at these decisions in light of the OCS budget, which I have not seen either. And so I'd like it to go back to Committee first, or go to Committee first, it hasn't gone to Committee yet. Thank you.

CHAIR WHITE: Yeah. The issue here is, by doing it this way, the Director of Council Services' salary will not be tied to the Prosecutor and the Corp. Counsel salaries.

COUNCILMEMBER KING: I understand the situation.

CHAIR WHITE: And therefore, by doing it this way we're also excusing that process from any actions by the Salary Commission as well.

So, anyway.

Mr. Guzman.

COUNCILMEMBER GUZMAN: Thank you, Chair.

I just have a question as to why would we want to deviate from a Countywide policy or a formula that is set for the attorneys?

You could either go higher or lower than Prosecutors or Corp. Counsel and that would seem unfair to those attorneys in those departments. Or you, logically, just doesn't seem like it would be fair. And so I think we need to, a little bit, I mean we can bifurcate that particular item, but I would like to vet it through a little more as to what are the reasons why we would deviate from the countywide formula on salary for the attorneys.

- CHAIR WHITE: Well, as you know, the position does not require an attorney and so it leaves us the flexibility to set it lower if we so choose or higher if we so choose.
- COUNCILMEMBER GUZMAN: Oh, I apologize. I was referring to the, oh, the, I guess the new position for the, um, the attorney supervising, oh wait, the Supervising Legislative Attorney, yeah, yeah, that's what I'm speaking on --
- CHAIR WHITE: Oh, I'm sorry, okay.
- COUNCILMEMBER GUZMAN: -- but, I don't know about the other items because it was a motion that basically brought four items together. So, not sure how we are going to discuss these various items in one full motion. So, that's what I'm speaking on, is the item No. 17-36. I'm not sure what Ms. King was speaking on.
- CHAIR WHITE: Yeah, I believe the order would be to vote on an amended version of Bill 1, initially. Then we would have a separate vote on setting the salary, and then a separate vote on approving the appointment of Gregory Garneau as the Supervising Legislative Attorney.
- COUNCILMEMBER GUZMAN: Yeah, I realize that Chair. But the motion was all four put together on the waiver, so I don't know how you are going to distinguish the separate issues in each of them. Because, Mr. Carroll, motioned for all four items to be –
- CHAIR WHITE: I believe the waiver was just on Bill 1. We don't, because the others are, the others are resolutions.

Let's take a brief recess.

COUNCILMEMBER GUZMAN: Alright. Thank you.

(THE MEETING WAS RECESSED BY THE CHAIR AT 10:22 A.M., AND WAS RECONVENED AT 10:33 A.M., WITH ALL MEMBERS PRESENT, EXCEPT FOR COUNCILMEMBER HOKAMA, EXCUSED.)

Members we have a, we have a simple vote on a waiver and if we vote to waive the rules, we need six Members. And with the waiver, we can act on these items today, without the waiver, then the Chair will recommend that we simply send it to the PEA Committee for further consideration.

So, again the vote is on the waiver. So is there any further discussion? Seeing none, all those in favor of the waiver, please signify by saying "aye".
