A BILL FOR AN ORDINANCE REPEALING SECTION 13.16.040, MAUI COUNTY CODE, RELATING TO THE GOLF COURSE SPECIAL FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 13.16.040, Maui County Code, is repealed in its entirety.

SECTION 2. All encumbrances and any balance remaining in the golf course special fund as of June 30, 2018, shall be transferred to the general fund.

SECTION 3. This ordinance shall take effect on July 1, 2018.
