A BILL FOR AN ORDINANCE AMENDING
THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI,
APPENDIX A, PART I, DEPARTMENT OF POLICE,
HAWAII CRIMINAL JUSTICE DATA CENTER –
NATIONAL CRIMINAL HISTORY RECORDS IMPROVEMENT PROGRAM

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended “Fiscal Year 2025 Budget”, Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2025, is amended to add a new appropriation under the Department of Police, entitled “Hawaii Criminal Justice Data Center – National Criminal History Records Improvement Program”, in the amount of, \$456,993, to read as follows:




