

AUTHORIZING SETTLEMENT OF JMC CLAIM  
4086753, COUNTY OF MAUI RISK FILE 2023-  
1128 OF JEFFREY NAVARES

WHEREAS, on November 13, 2023, Claimant Jeffrey Navares filed JMC Claim 4086753, County of Maui Risk File 2023-1128, for property damage to his home located at 139 Meheu Circle, Kahului, Hawai'i, from an alleged misdirected County water sprinkler occurring on or about October 27, 2023, for which three repair estimates came in between \$62,986.66 and \$81,906.35; and

WHEREAS, the County of Maui, to avoid incurring expenses and the uncertainty of a judicial determination of the parties' respective rights and liabilities, will attempt to reach a resolution by way of a negotiated settlement or Offer of Judgment; and

WHEREAS, having reviewed the facts and circumstances regarding this case and being advised of attempts to reach a resolution by way of a negotiated settlement by the Department of the Corporation Counsel, the Council wishes to authorize the settlement; now, therefore,


BE IT RESOLVED by the Council of the County of Maui:

1. That under Section 3.16.020, Maui County Code, it approves settlement of JMC Claim 4086753, County of Maui Risk File 2023-1128 by Claimant Jeffrey Navares in the amount of \$62,986.66;
2. That it authorizes the Mayor to execute a Release and Settlement Agreement on behalf of the County, under terms and conditions as may be imposed by the Corporation Counsel consistent with the Council's settlement approval;
3. That it authorizes the Director of Finance to satisfy the settlement of this case, under terms and conditions as may be imposed by the Corporation Counsel, consistent with the Council's settlement approval; and
