

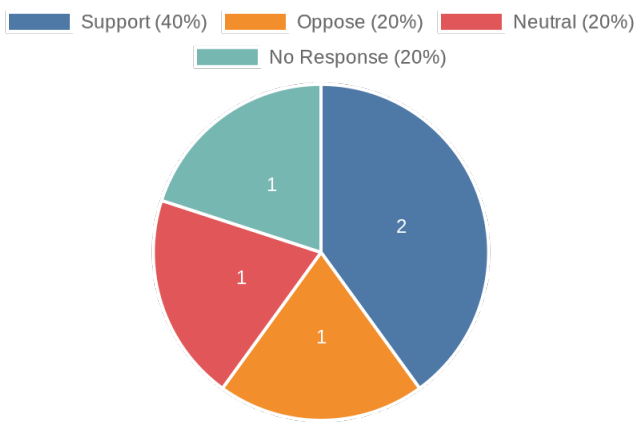

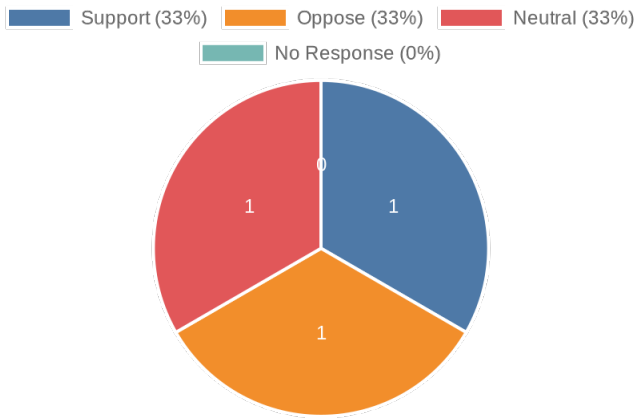

Aloha Chair and Committee Members,

I am submitting testimony on behalf of Ho_oikaika Partnership, a countywide coalition that brings together health and human service providers, community organizations, and public agencies to prevent child abuse and build a stronger, more coordinated system of support for our _ohana. We focus on strengthening protective factors so families can thrive and challenges do not escalate into crisis.

April is Child Abuse Prevention Month. Last year, this Council unanimously recognized that in Resolution 25-92, affirming the County's shared kuleana to protect keiki and support our _ohana and workforce. You also unanimously approved \$175,000 for our work. That investment was meaningful, and our 2025 outcomes reflect it.

We applied for FY27-28 funding through the Department of Human Concerns RFP process. However, the Mayor's proposed FY 27 budget does not include Ho_oikaika Partnership. I am writing on behalf of Ho_oikaika Partnership to respectfully request that the Council include a dedicated funding line of \$199,200 in the FY27 budget, sustaining and modestly increasing support for something proven and essential. This is not an investment in one program. It is an investment in a stronger, more connected system of care for all of Maui County. When we invest in prevention, we reduce long-term costs, strengthen our workforce, and ensure that all our keiki and _ohana are healthy, safe, and supported. A more detailed explanation is attached.

The MPD is the County's largest proposed departmental expense at \$140M next year, a 10% increase. Yet, the budget is missing how to address MPD's repeated and ongoing illegal signing of federal contracts behind the backs of this Council and the failure of the MPD to comply with the state statute UIPA on sunshine and transparency.

The MPD is demonstrating it cannot meet statutory requirements and deadlines on something as simple as bringing forward for your approval and publicly revealing contracts it wants to make or has already made with the federal government.. We're talking ICE contracts and contracts with other already mobilized elements of Trump's Police State that is the subject of much current debate before the Council. We hope the Council has seen the Corporation Counsel's opinion this last week vindicating Maui Indivisible's position that the MPD is not respecting the Council's authority.

Not only is the MPD violating state laws and legal deadlines, it is doing so despite repeated and escalating interventions by the State Office of Information Practices. In addition to breaking the law repeatedly, this MPD practice is wasting our County and state tax-dollar resources by churning unnecessary administrative and litigious communications on all ends.

The N&K CPAs FY25 Annual Comprehensive Financial Report on page 34 says that County had a "savings in the Police Department of \$5.5 million" from what was budgeted. So this is not a matter of lack of resources provided to MPD. In fact, of the 5 new and 66 re-organized named positions in the Mayor's 2027 MPD budget, none are in the Records Office which tracks and retrieves these federal contracts.

Regardless of whether these MPD decisions are intentional or just incompetence, the Council should tie taxpayer funding of the MPD to measurable compliance with state laws 46-7 and the UIPA, adopting an independent audit of compliance to state laws, and require ongoing quarterly reporting to the Council based on a corrective action plan with a goal of 100% compliance. The County has implemented both audits and corrective action plans when it comes to collecting the outstanding \$4.4M in short-term rental tax compliance and violations. There is no reason why the County cannot implement a similar regime for MPD compliance and law violations.

Just because the County makes the police its highest departmental financial priority doesn't put the MPD above the law. We, the taxpayers, deserve and have a right to know what the MPD is doing with our money. The Council is the County's government body with the most sunshine. There is a reason why the state legislature forces by law the MPD to come to the Council to approve federal contracts and to make its records open to the public. The MPD is not a private club. We deserve and have rights to sunshine and transparency. We also deserve an MPD that obeys the law and sets a good example for our community. That, unfortunately is not happening yet. The Council has the power of the purse and thus the responsibility to ensure we are a County of laws and equal treatment.

Specifically, I would like to address Item 12.b. on page 10 of the correspondence to Ms. Jessica Crouse, Acting Director Department of Human Concerns (which relates to the Department's inquiry about whether the Coalition has a dedicated site to provide rides and services)

While MMBC does privately lease, fund, and operate the West Maui Bike Park in Napili for free public use, it is important to emphasize that the Cycle Strong program is designed as a mobile initiative. The grant we have requested is specifically intended to fund a mobile bike clinic, including the purchase of a trailer and additional bikes.

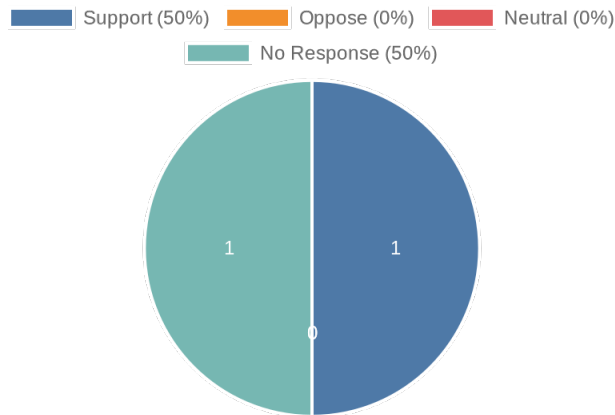
The rationale for this mobile model is rooted in our commitment to equity and access: For many of Maui's youth, the lack of reliable transportation is a significant hurdle to participating in healthy recreational activities. By utilizing a mobile trailer, we can travel directly to schools, youth sites, and underserved neighborhoods biking instruction to the students where they are.

We believe that this mobile outreach is the most effective way to reach our target goals of serving hundreds of students annually through school-based clinics.

Thank you for your time and for your consideration of this program, which we believe will foster stronger community connections and resilience for our youth.

Aloha Councilmembers,

My name is Aaron “Moose” Reichert, owner of Krank Cycles Maui. For over 25 years, I’ve worked with youth on Maui—mentoring, repairing, and giving away thousands of bicycles to keiki across our community.

To answer question 12(b): Yes, the Maui Mountain Bike Coalition does have active sites for riding and service. These include ongoing trail stewardship and development areas in Makawao Forest Reserve, as well as the new Napili Community Bike Park in West Maui. These are not just riding areas—they are spaces where youth learn responsibility, stewardship, and community.

From firsthand experience, especially after the Lahaina fires, I can tell you that bicycles have been one of the most powerful tools for healing. We gave away over 1,400 bikes after the fires, and another 500 bikes to kids at Christmas, primarily to Lahaina fire survivors. What we saw was immediate—kids getting outside, reconnecting with friends, moving their bodies, and beginning to process trauma in a healthy way.

Right now, many of our keiki are struggling with increased screen time, anxiety, depression, and declining physical health. Bikes provide a simple, proven solution—movement, independence, and connection.

The County already has strong safety and youth programs, but in our experience, they often face limitations in staffing and mobility. Programs are not always able to reach communities consistently, especially in more remote or impacted areas.

This is where Cycle Strong fills a critical gap.

A mobile bike program allows us to bring bikes, safety education, and mentorship directly into schools and communities—meeting kids where they are. This model is proven on the mainland, where mobile bike units and safety programs have significantly increased youth participation, safety awareness, and physical activity.

With this support, we can partner with existing County efforts, including Parks & Recreation and Maui Police Department, to expand bike safety education and youth engagement. A mobile unit would also allow us to serve Moloka_i and L_na_i—ensuring these communities are not left behind.

This is not duplicating services—it is strengthening and extending them.

We have the experience, the community trust, and the infrastructure to make this successful immediately.

Aloha Chair and Councilmembers,

My name is Deb Marois. I serve as Coordinator for Ho'oiikaika Partnership. Mahalo for the opportunity to testify, and for your continued commitment to strengthening families in Maui County.

Ho'oiikaika Partnership is a countywide coalition that brings together health and human service providers, community organizations, and public agencies to prevent child abuse and build a stronger, more coordinated system of support for our 'ohana. We focus on strengthening protective factors so families can thrive and challenges do not escalate into crisis.

April is Child Abuse Prevention Month. Last year, this Council unanimously recognized that in Resolution 25-92, affirming the County's shared kuleana to protect keiki and support our 'ohana and workforce. You also unanimously approved \$175,000 for our work. That investment was meaningful, and our 2025 outcomes reflect it.

You Have Already Said This Matters

In Resolution 25-92, this Council affirmed that cross-sector collaboration creates a seamless safety net for families; that Healing the Healers demonstrates the need for ongoing workforce investment; that the 2023 wildfires placed extraordinary demands on our social service providers; and that the County has a moral obligation to protect every child on Maui, Moloka'i, and Lāna'i. Those words were not ceremonial. We are asking that you fund them.

The Need Has Not Gone Away

As we discussed in January, nearly 1 in 5 adults in Maui County report having four or more Adverse Childhood Experiences (ACEs) before age 18, traumatic events that increase lifelong risks of chronic disease, mental illness, substance use, and child welfare involvement. That statistic was measured *before* the 2023 wildfires.

Two-plus years later, families are still struggling. Providers are still stretched thin. Federal funding is contracting. And for a coalition whose strength lies in coordination, consistency, and trust, funding gaps are deeply destabilizing.

We experienced exactly that in 2025. A delayed grant release forced us to pause both Navigation Services and Healing the Healers for several months. We lost a key staff member and contractor. Navigation Services were only restored to full-time capacity in February; Healing the Healers relaunched just last month. Both are currently funded only through June 30. That disruption affects

more than programs. It affects families seeking help, and providers who rely on a coordinated system to do their work. That is the real cost of fragmented, year-to-year funding.

Prevention requires consistency. Trust is built over time, and damaged when services disappear and reappear. County investment would provide the stability needed for continued success.

What Your FY26 Investment Achieved

In 2025, Ho’oikaika Partnership made progress across all five strategic goals, engaging dozens of agencies and hundreds of providers to strengthen coordination, reduce duplication, and improve how services reach families.

- The HP Navigator served 161 families representing 527 individuals, including families from Moloka’i and Lāna’i, helping them access food, clothing, and critical resources.
- HP engaged 3,910 families through 13 outreach events across the county and distributed more than 1,000 prevention and basic-needs items.
- 190 providers from 50 organizations attended our first in-person conference since 2019. 96% said it met or exceeded expectations; 90% gained new tools applicable to their work.
- Healing the Healers supported 54 providers from 23 agencies. 90% reported stronger peer connections and new strategies to prevent burnout.
- 95 people from 58 different organizations participated in monthly coalition meetings. 98% reported increased understanding of community resources, strengthening referral pathways and reducing duplication across the system.

Coordination Is a Direct Service

Research shows that every dollar invested in child abuse prevention yields up to \$7 in savings through reduced healthcare costs, lower incarceration rates, and decreased reliance on emergency services. Ho’oikaika Partnership is that upstream investment.

In a coalition model that uses a systems change approach; coordination is a direct service. Without it, 75 agencies stay siloed, families fall through cracks, and every other dollar invested in this system becomes less effective. The Navigator who knows the families on Moloka’i and in Hāna. The Healing the Healers facilitators who have earned the trust of frontline providers. The monthly meeting that keeps agencies coordinated: These take years to build and can be lost in a budget cycle.

Our coalition leverages funding from state agencies, philanthropy, and partner agency resources but the landscape is shifting. The Maui Strong Fund that supported much of our post-wildfire surge has wound down. Federal funding is less certain. County support is the stable, local investment that enables the whole system to function seamlessly.

A Request to Sustain What Works

Ho’oikaika Partnership is Maui County's infrastructure for prevention. It is an 18-year-old coalition with demonstrated results, rigorous evaluation, and deep roots throughout the community. The primary challenge we face is not lack of impact. It is lack of stable funding.

We are requesting \$199,202 for FY27, a modest increase from last year that reflects the true cost of full-year Navigation Services, Healing the Healers, concrete support for families, public education, and

the workforce coordination, evaluation and communications infrastructure that holds everything together. With this investment, we will:

- Restore full-time Navigation Services for 150–200 families, including those from Moloka‘i, Lāna‘i, and Hāna;
- Continue workforce support and prevent burnout through Healing the Healers and other professional development;
- Reach thousands of residents with public education materials promoting protective factors and community resources; and
- Coordinate over 75 partner organizations to fill gaps, share resources, and prevent duplication so that every dollar invested in Maui's families goes further.

This is not an investment in one program. It is an investment in a stronger, more connected system of care for all of Maui County. Please include a line item for Ho‘oikaika Partnership in the FY27 budget. When we invest in prevention, we reduce long-term costs, strengthen our workforce, and ensure that all our keiki and ‘ohana are healthy, safe, and supported.

Aloha Chair, and members of the Council. My name is Emily Erickson, and I am the Executive Director of The Maui Farm. I took over daily operations in October 2025 after serving for 15 years on the board of directors. I am here today to speak in **strong support** of the Mayor's proposed budget, specifically, The Maui Farm. We are respectfully requesting an increase in our allocation this year of \$43,638 above last year's funding level.

The "Why"

The Maui Farm has been in operation on County-leased land for 40 Years. We serve as transitional housing with a farm component, providing a safe community and a healing lifestyle for families facing homelessness. Our Family Strengthening Program operates **five residential homes** where we integrate life-skills training with the therapeutic power of the land and our animals. Each home is shared by 2 or more families; we currently have 8 Mommies and 15 Keiki living at The Maui Farm.

Homelessness is at a crisis level in our state. Our families typically come to live with us for a year. While they are with us, we help them pay off debt, repair or purchase vehicles, maintain a monthly budget, secure childcare and employment, and eventually find long-term housing.

Our county grant makes up 1/3 of our overall budget. We make up the remaining shortfall with private grants, donations, and fundraising.

The Solution

The challenge we face is the reality of operating our facility in today's economy. This requested \$43,638 increase is a direct solution to inflationary pressures, the rising cost of animal feed, utilities, cost of living salaries, and essential farm and housing maintenance required to keep our five residential homes safe and functional.

Conclusion

Investing in The Maui Farm is an investment in our island community proven by four decades of success. By approving this \$43,638 amendment, you are ensuring that our Makawao farm remains a place of hope and resilience. I urge the Council **to support the Mayor's budget and approve our requested increase.** Mahalo.

Testimony 1 from a current resident at The Maui Farm

My name is Brandy Dias-Christian and I am writing in support of the Maui Farm family strengthening program. I have lived at the Maui Farm for 3 months and have participated in the Family strengthening program.

Before I came to the Maui Farm, I was at the Women Helping Maui shelter. I literally had the clothes on my back, no identification, and nothing else.

Being that I had a limited time there I was so stressed and had no idea of where I would go or what I would do, because I lost everything. One of the advocates at Women Helping Women told me that I should put into an application into the Maui Farms.

The relief of me getting accepted into the farm was a life saver. Honestly, If I did not have this place I would have no choice but to be homeless, and probably go back to my abuser. I feel so blessed to be in a safe, supportive place in where I have my own room in which I feel more independent and comfortable.

The staff here is golden, each one of them has a way of making me feel that I can be open, honest, and gives me the strength to look to the future. Each of them individually has a soft approach which makes me feel so comfortable being that I came from a very abusive environment before. Not only that, they are always open to listen to me venting or just getting things off my mind. I owe the Maui Farms my life. If it wasn't for the Maui Farms, I honestly would not have made it and wouldn't be alive because I would have to go back to my abusive situation in which I barely escaped.

FY27 Residency Area Meeting April 1, 2026

Aloha Chair and Councilmembers,

My name is Deb Marois. I serve as Coordinator for Ho'oikaika Partnership. Mahalo for the opportunity to testify, and for your continued commitment to strengthening families in Maui County.

Ho'oikaika Partnership is a countywide coalition that brings together health and human service providers, community organizations, and public agencies to prevent child abuse and build a stronger, more coordinated system of support for our 'ohana. We focus on strengthening protective factors so families can thrive and challenges do not escalate into crisis.

April is Child Abuse Prevention Month. Last year, this Council unanimously recognized that in Resolution 25-92, affirming the County's shared kuleana to protect keiki and support our 'ohana and workforce. You also unanimously approved \$175,000 for our work. That investment was meaningful, and our 2025 outcomes reflect it.

We applied for FY27-28 funding through the Department of Human Concerns RFP process. However, the Mayor's proposed FY 27 budget does not include Ho'oikaika Partnership. I am writing on behalf of Ho'oikaika Partnership to respectfully request that the Council include a dedicated funding line of \$199,200 in the FY27 budget, sustaining and modestly increasing support for something proven and essential.

You Have Already Said This Matters

In Resolution 25-92, this Council affirmed that cross-sector collaboration creates a seamless safety net for families; that Healing the Healers demonstrates the need for ongoing workforce investment; that the 2023 wildfires placed extraordinary demands on our social service providers; and that the County has a moral obligation to protect every child on Maui, Moloka'i, and Lāna'i. Those words were not ceremonial. We are asking that you fund them.

The Need Has Not Gone Away

As we discussed in January, nearly 1 in 5 adults in Maui County report having four or more Adverse Childhood Experiences (ACEs) before age 18, traumatic events that increase lifelong risks of chronic disease, mental illness, substance use, and child welfare involvement. That statistic was measured *before* the 2023 wildfires.

Two-plus years later, families are still struggling. Providers are still stretched thin. Federal funding is contracting. And for a coalition whose strength lies in coordination, consistency, and trust, funding gaps are deeply destabilizing.

We experienced exactly that in 2025. A delayed grant release forced us to pause both Navigation Services and Healing the Healers for several months. We lost a key staff member and contractor. Navigation Services were only restored to full-time capacity in February; Healing the Healers relaunched just last month. Both are currently funded only through June 30. That disruption affects

more than programs. It affects families seeking help, and providers who rely on a coordinated system to do their work. That is the real cost of fragmented, year-to-year funding.

Prevention requires consistency. Trust is built over time, and damaged when services disappear and reappear. County investment would provide the stability needed for continued success.

What Your FY26 Investment Achieved

In 2025, Ho’oikaika Partnership made progress across all five strategic goals, engaging dozens of agencies and hundreds of providers to strengthen coordination, reduce duplication, and improve how services reach families.

- The HP Navigator served 161 families representing 527 individuals, including families from Moloka’i and Lāna’i, helping them access food, clothing, and critical resources.
- HP engaged 3,910 families through 13 outreach events across the county and distributed more than 1,000 prevention and basic-needs items.
- 190 providers from 50 organizations attended our first in-person conference since 2019. 96% said it met or exceeded expectations; 90% gained new tools applicable to their work.
- Healing the Healers supported 54 providers from 23 agencies. 90% reported stronger peer connections and new strategies to prevent burnout.
- 95 people from 58 different organizations participated in monthly coalition meetings. 98% reported increased understanding of community resources, strengthening referral pathways and reducing duplication across the system.

Coordination Is a Direct Service

Research shows that every dollar invested in child abuse prevention yields up to \$7 in savings through reduced healthcare costs, lower incarceration rates, and decreased reliance on emergency services. Ho’oikaika Partnership is that upstream investment.

In a coalition model that uses a systems change approach; coordination is a direct service. Without it, 75 agencies stay siloed, families fall through cracks, and every other dollar invested in this system becomes less effective. The Navigator who knows the families on Moloka’i and in Hāna. The Healing the Healers facilitators who have earned the trust of frontline providers. The monthly meeting that keeps agencies coordinated: These take years to build and can be lost in a budget cycle.

Our coalition leverages funding from state agencies, philanthropy, and partner agency resources but the landscape is shifting. The Maui Strong Fund that supported much of our post-wildfire surge has wound down. Federal funding is less certain. County support is the stable, local investment that enables the whole system to function seamlessly.

A Request to Sustain What Works

Ho’oikaika Partnership is Maui County’s infrastructure for prevention. It is an 18-year-old coalition with demonstrated results, rigorous evaluation, and deep roots throughout the community. The primary challenge we face is not lack of impact. It is lack of stable funding.

We are requesting \$199,202 for FY27, a modest increase from last year that reflects the true cost of full-year Navigation Services, Healing the Healers, concrete support for families, public education, and

the workforce coordination, evaluation and communications infrastructure that holds everything together. With this investment, we will:

- Restore full-time Navigation Services for 150–200 families, including those from Molokaʻi, Lānaʻi, and Hāna;
- Continue workforce support and prevent burnout through Healing the Healers and other professional development;
- Reach thousands of residents with public education materials promoting protective factors and community resources; and
- Coordinate over 75 partner organizations to fill gaps, share resources, and prevent duplication so that every dollar invested in Maui's families goes further.

This is not an investment in one program. It is an investment in a stronger, more connected system of care for all of Maui County. Please include a line item for Hoʻoikaika Partnership in the FY27 budget. When we invest in prevention, we reduce long-term costs, strengthen our workforce, and ensure that all our keiki and ʻohana are healthy, safe, and supported.

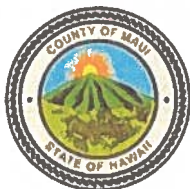
