SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2018 BUDGET

On behalf of the Department of Transportation, I am transmitting the attached proposed bill for the purpose of increasing the FY 2018 appropriations for the Human Services Transportation Program and Public Transit Program to allocate additional funding requested by Maui Economic Opportunity, Inc. (MEO).

As stated in the attached correspondence from MEO Chief Executive Officer Debbie Cabebe, MEO is requesting an additional \$39,141, under the Human Services Transportation Program and \$54,276 under the Public Transit Program to satisfy terms of a recently ratified collective bargaining agreement requiring that MEO offer wage increases and supplemental premium pay to its human services drivers and annual leave benefits to its paratransit drivers.

Attached is a Certification of Additional Revenues for Fiscal Year 2018 certifying the availability of General Fund Carryover/Savings in the amount of \$39,141 and Highway Fund Carryover/Savings in the amount of \$54,276 to fund this request.

Dear Mr. Medeiros:

As you are aware, MEO has been negotiating with the Hawaii Teamsters & Allied Workers, Local 996 for the past two years. On Sunday, July 30, 2017 the Puunene drivers ratified the contract.

Based on the terms of the contract MEO is required to offer annual leave benefits to the Paratransit Drivers. They currently do not incur these benefits. The contracts states, "Subject to additional funding by Maui County, Paratransit Drivers will accrue annual leave beginning July 1, 2017 in accordance with Section 17.4 or upon such date after July 1, 2017 that such additional funding occurs."

Another provision requires that MEO provide a .40 raise to all human services drivers making less than \$19.00 per hour and premium pay supplement of \$50.00 per month for drivers making \$19.00 and above who work at least 100 hours per month. The contract states, "The premium pay supplement shall not be considered compensation for the purposes of calculating overtime." Both of these conditions are also subject to MEO receiving additional funding from Maui County.

MEO submitted a request for a three percent increase for this fiscal year, unfortunately the request was not funded by Council.

At the close of the last fiscal year, (July 1, 2016-June 30, 2017), MEO returned \$38,116.00 in unspent funds under its Human Service contract. This savings was due to less than projected fringe benefits costs due open positions, lower than budgeted mileage reimbursement expenses, lower than expected equipment repair and maintenance costs, and fuel, a decrease in vehicle insurance premiums due to disposal of older buses, and lower than expected software licensing fees for Ecolane and contracts and consultants. Many of these items are difficult to budget to the exact dollar, therefore there are fiscal years where savings are realized and funds are returned to the County. If MEO runs short during the year, we have not been able to seek additional funds.

The Paratransit is based on fee for service, therefore we only receive funds based on billable hours. Due to the efficiency of the Ecolane system we only billed the full budgeted amount in one of the last four years of the contract.

Having said that, I respectfully request additional funds for fiscal year July 1, 2017 – June 30, 2018 to comply with the terms of the Collective Bargaining Agreement (CBA). We request at least \$39,141.00 to cover negotiated wage adjustments for the Human Service CDL Drivers and at least \$54,276.00 additional funds to provide Paratransit drivers with paid annual leave. The current structure of the paratransit contract does not allow us to bill for anything other than billable hours.

In accordance with the terms and conditions of MEO's County contracts, any unspent funds will be returned to the County at the end of the fiscal year.

We apologize for any inconvenience this may cause and look forward to your response.
