SETTING THE ANNUAL SALARY FOR THE INVESTIGATOR OF THE BOARD OF ETHICS UNDER SECTION 2.56.080, MAUI COUNTY CODE

WHEREAS, Section 2.56.080(A), Maui County Code, states: "The annual salary for all board of ethics staff must be set by the council by resolution within the pay range and pay scales established in this section"; and

WHEREAS, Code Section 2.56.080(C) states: "The annual salary for the investigator" is set within a scale; and

WHEREAS, Code Section 2.56.080(E) states: "The investigator and administrative assistant may be hired on a part-time basis. If either position is filled on a part-time basis, each position's annual salary will be calculated on a pro-rata basis based on the employee's set part-time hours"; and

WHEREAS, the Executive Director and Legal Counsel of the Board of Ethics hopes to hire an investigator with a salary set at Step J of the scale established by Code Section 2.56.080(C) on a part-time basis of 19 hours per week; and

WHEREAS, on September 8, 2025, the Council adopted Resolution 25-170, FD1, which did not account for the Investigator's part-time status; now, therefore,

#### BE IT RESOLVED by the Council of the County of Maui:

- 1. That the annual salary for the Investigator of the Board of Ethics is set at a pro-rata basis of 19 hours per week for Step J under Section 2.56.080(C), Maui County Code, effective upon adoption;
- 2. That Resolution 25-170, FD1, is superseded by this Resolution; and
- 3. That certified copies of this Resolution be transmitted to the Mayor; Corporation Counsel; Director of Finance; Executive Director and Legal Counsel, Board of Ethics; and Chair, Board of Ethics.
