WENT OFF TRACK AND BET YOU MR. COOK CAN APPRECIATE THIS BECAUSE HE IS BORN THE YEAR OF THE HORSE. I THINK WE WENT TOO FAR. EVERYBODY KNOWS OIL IS KIND OF RUINING THE WORLD. SOMEWHERE WE WENT OFF THE PATH OF HORSES AND OXES AND I KNOW IT IS MORE CONVENIENT AND ALL TO DRIVE YOUR CAR TO WORK. I WOULD LIKE A CAR TO DRIVE OVER HERE, BUT PLEASE MORE PEOPLE DRIVE THE BUSES.
