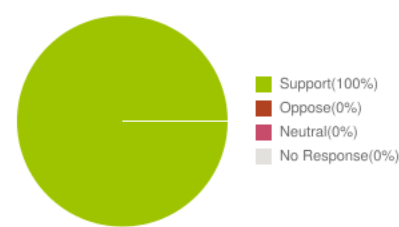

Overall Sentiment

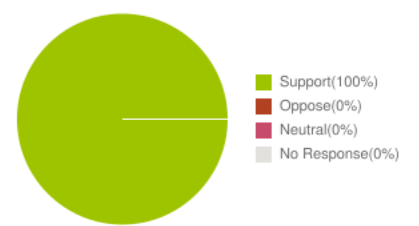

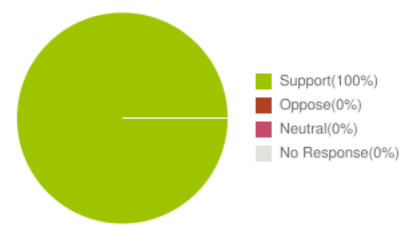

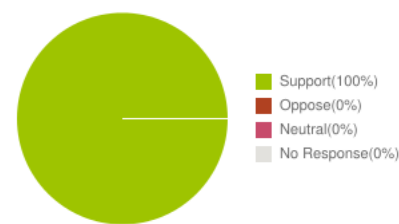

Overall Sentiment



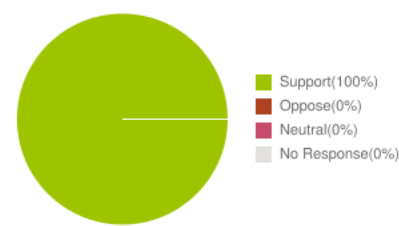

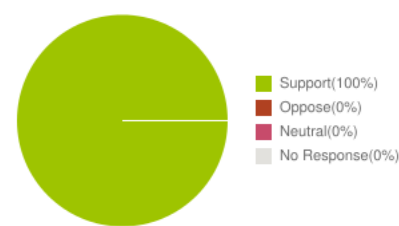
