On behalf of the Department of Water Supply, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI, REVENUES AND DEPARTMENT OF WATER SUPPLY, ADMINISTRATION PROGRAM, EAST MAUI WATER AUTHORITY STUDY."

The purpose of the proposed bill is to amend the Fiscal Year 2025 Budget to increase Carryover/Savings in the Water Fund and Total Estimated Revenues by \$250,000, increase Department of Water Supply, Administration Program, General, Category B – Operations & Equipment and Total in the amount of \$250,000, insert conditional language for professional services for a contract to prepare a feasibility study and management or business plan for the East Maui

Water Authority, and increase the Total Operating Appropriations and Total Appropriations by \$250,000.

A procurement for buyer side due diligence services was advertised and two proposals were received, but the selected consultant's legal counsel requested additional time to review the contract, and the funds were not encumbered by the end of the Fiscal Year.
