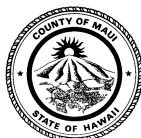

Dear Governor Green:

SUBJECT: UPDATE ON MAUI WILDFIRE EXPOSURE COHORT STUDY (WASSP-1(10))

At its meeting of July 21, 2025, the Maui County Council's Water Authority, Social Services, and Parks Committee received an update on the Maui Wildfire Exposure Cohort Study and discussed the report, entitled "From Crisis to Recovery: Health and Resilience Two Years After the Maui Wildfires, June 18, 2025." The report identified the continued emotional, physical, and social effects impacting Maui residents after the August 2023 Maui wildfires. MauiWES is the largest post-disaster health cohort in Hawai'i's history, which in its second year, now follows 2,000 adults and children to better understand how the community is healing and identify where additional support is needed.

A few highlights of the report show that of the total adult participants:

- Forty-one percent report worse health compared to the prior year;
- Half show depressive symptoms, 26 percent report moderate-to-severe anxiety, and 4.2 percent have had suicidal thoughts in the past month;

- Seventy-four percent have elevated or hypertensive blood pressure, while a quarter show reduced lung function;
- Forty-one percent are still living in temporary housing; and
- Twenty-five percent remain unemployed but are actively looking for work.

Of the child participants:

- Over half, or 51 percent, ages 10 to 17, screen positive for depression, with 22 percent in the severe range;
- About 30 percent report anxiety symptoms and nearly 45 percent still show signs of PTSD, with 4.3 percent at severe levels;
- One in three children have elevated or high blood pressure; and
- Nearly 20 percent have impaired breathing capacity, especially among Asian and Filipino children.

There is much more work to be done to assist our Maui community. I respectfully urge your continued advocacy and financial backing for this initiative.

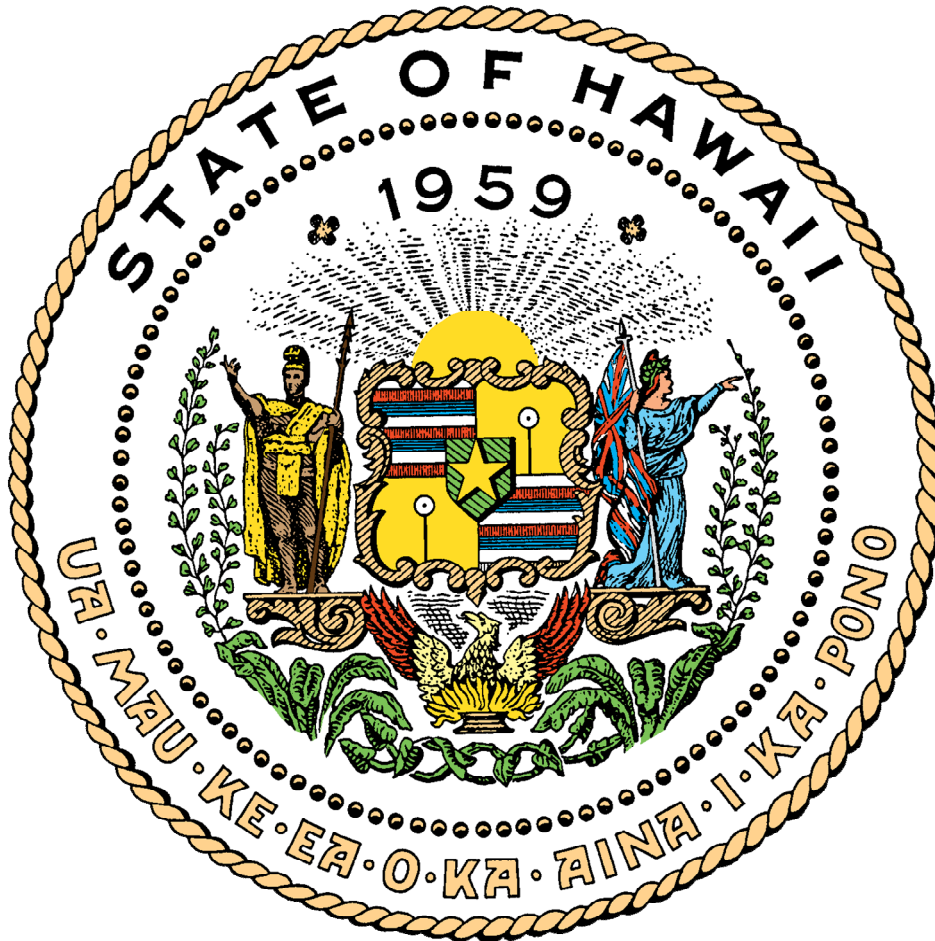
