A BILL FOR AN ORDINANCE AMENDING
THE FISCAL YEAR 2026 BUDGET; APPENDIX A, PART I;
OFFICE OF THE MAYOR; ENERGY EFFICIENCY AND
CONSERVATION BLOCK GRANT; NEW APPROPRIATION
OF \$80,750

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5816, "Fiscal Year 2026 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2026, is amended to add a new appropriation for the Office of the Mayor entitled "Energy Efficiency and Conservation Block Grant" in the amount of \$80,750, to read as follows:


