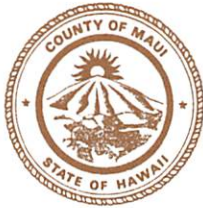

SUBJECT: AMENDMENT TO THE FISCAL YEAR 2019 BUDGET

I am transmitting the attached proposed bill for the purpose of amending Appendix C – Capital Improvement Projects to revise the project description for Countywide Equipment under the Department of Finance as it pertains to the appropriation of two 1500 GPM pumper trucks for the Napili and Wailuku Fire Stations. The description is revised to Kihei and Napili Fire Stations to match the allocation as listed in the appropriation ordinance.

The bill also proposes revising the project description for the Public Safety Radio System Replacement project under the Department of Management to allow for improvements to be completed at project sites in Makila (Lahaina) and Waiakeakua (Lanai). Improvements in Makila are needed to resolve a long-standing vulnerability for voice and data services in West Maui. Additional funding for Waiakeakua is needed to cover cost overruns due to delays in the project which required additional electrical service testing.

A BILL FOR AN ORDINANCE AMENDING
THE FISCAL YEAR 2019 BUDGET FOR THE COUNTY OF MAUI
AS IT PERTAINS TO APPENDIX C - CAPITAL IMPROVEMENT PROJECTS,
DEPARTMENT OF FINANCE, COUNTYWIDE, COUNTYWIDE EQUIPMENT;
DEPARTMENT OF MANAGEMENT, COUNTYWIDE,
PUBLIC SAFETY RADIO SYSTEM REPLACEMENT

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4861, Bill No. 57 (2018), as amended, "Fiscal Year 2019 Budget", Appendix C – Capital Improvement Projects, is hereby amended as it pertains to the Department of Finance, Countywide, by revising the project description for Countywide Equipment, to read as follows:
