

Reasons:

- 1. There is a cluster of agencies off Baldwin Avenue that provide support services for Maui's youth and families. These agencies are geographically isolated and currently unserved by public transportation. Not having public transportation imposes a hardship on those needing to access places such as their jobs, other services and supports, and court.
- 2. There is currently no way for Upcountry residents to get to Paia Town and points beyond from Makawao Town without going to Kahului (and through the airport loop) first. Let's change that!
