A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, INCREASING ESTIMATED REVENUES, CARRYOVER/SAVINGS, GENERAL FUND BY \$5,000,000, CAPITAL IMPROVEMENT PROJECTS AND APPENDIX C, DEPARTMENT OF PARKS AND RECREATION, COUNTYWIDE, INCREASE APPROPRIATION FOR COUNTYWIDE PARKS FACILITIES BY \$1,200,000, PĀ'IA-HA'IKŪ COMMUNITY PLAN AREA, ADD NEW APPROPRIATION FOR LOWER PAIA PARK PARKING LOT IN THE AMOUNT OF \$300,000, WAILUKU-KAHULUI COMMUNITY PLAN AREA, ADD NEW APPROPRIATIONS FOR WAR MEMORIAL GYM BUILDING IMPROVEMENTS IN THE AMOUNT OF \$2,000,000, AND WAR MEMORIAL FOOTBALL STADIUM AND TRACK REHABILITATION IN THE AMOUNT OF \$1,500,000

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5816, as amended, "Fiscal Year 2026 Budget," Section 2, Estimated Revenues, is amended to increase Carryover/Savings, General Fund in the amount of \$5,000,000, and increase the total accordingly, to read as follows:

	The proposed new Pā‘ia Gym is essential for addressing the growing demand for safe, accessible recreational facilities in the North Shore area of Maui. The existing gym has been closed for several years due to significant safety concerns, leaving a gap in recreational services for residents, particularly youth and senior citizens. This project aims to provide a modern, structurally sound facility that meets current safety standards and community needs. This project aligns with the County’s vision of providing sustainable public infrastructure. The new gym will also be designed for hurricane force winds and will serve as an emergency shelter.	
CBS-6073	<u>b. Lower Paia Park Parking Lot</u>	<u>300,000</u> ”
	<u>Design, permitting, and construction for parking lot improvements at the Lower Paia Park including installation of a temporary parking lot to be used during construction of the permanent lot. FY 2026 funding is for contract changes due to unforeseen conditions.</u>



	Repair of the retaining wall adjacent to the tennis court restrooms at Wells Park. The existing chain link fence will be removed and replaced. The existing concrete masonry unit will remain and a new mechanically stabilized earth wall will be installed in front of it.	
CBS-8928	c. Keōpūolani and Wells Park Pedestrian Lighting Replacement	4,000,000
	The Keōpūolani and Wells Park Pedestrian Lighting Replacement Project aims to enhance safety, accessibility, and energy efficiency by upgrading and installing new lighting systems. This project will address critical safety concerns by improving visibility in high-traffic pathways, parking lots, and park entrances during evening hours, fostering a secure environment for residents and visitors. Utilizing energy-efficient LED fixtures and smart lighting technology, the project aligns with Maui County’s sustainability goals by reducing energy consumption, maintenance costs, and environmental impact. This investment in pedestrian lighting will promote nighttime recreation, extend facility usability, and enhance public safety at these important facilities.

	Replastering and other related site repairs at Coach Soichi Sakamoto Pool.	
CBS-8934	e. Kahului Community Center Roof Replacement	250,000
	The Kahului Community Center Roof Replacement Project seeks funding for the removal and replacement of the existing roof, which is falling and no longer provides adequate protection to the facility. The current roof has suffered significant wear and tear due to age, weather, and environmental factors, resulting in leaks, water damage, and potential structural issues. The project will involve the demolition of the existing roofing materials and installation of a new, durable roofing system designed to withstand Maui’s harsh weather conditions, ensuring long-term functionality and safety. This critical project is essential to maintain the structural integrity of the building and ensure the continued availability of a safe, accessible space for local residents.	
CBS-4616	f. War Memorial Gym Building Improvements	1,200,000
	<u>Design, permitting, and construction management for facility-wide repairs and renovations. Work includes structural and exterior repairs, roof coating, electrical upgrades, visual fire alarm improvements, ADA upgrades to restrooms and locker rooms, and installation of air conditioning in the gym and office areas to meet current code. Scope also includes replacement of gym flooring, bleachers, and other ancillary improvements, along with a PV system and structural/facility upgrades needed for Enhanced Hurricane Protection Area (EHPA) Category 3 shelter requirements. FY 2026 funding is for contract changes due to unforeseen conditions.</u>


This bill proposes to amend the Fiscal Year 2026 Budget to 1) increase Estimated Revenues, Carryover/Savings, General Fund by \$5,000,000; 2) amend Capital Improvement Projects for Department of Parks and Recreation, Countywide, General Fund, to increase the appropriation for Countywide Parks Facilities in the amount of \$1,200,000, Pā'ia-Ha'ikū Community Plan Area, to add an appropriation for General Fund for "Lower Paia Park Parking Lot" in the amount of \$300,000, and Wailuku-Kahului Community Plan Area, to add appropriation for "War Memorial Gym Building Improvements" in the amount of \$2,000,000, and an appropriation for "War Memorial Football Stadium and Track Rehabilitation" in the amount of \$1,500,000; 3) increase the Total Capital Improvement Project Appropriations and Total Appropriations by \$5,000,000; and 4) amend Appendix C - Capital Improvement Projects, Department of Parks and Recreation, Countywide, to update the project description and increase the appropriation for Countywide Parks Facilities in the amount of \$1,200,000, Pā'ia-Ha'ikū Community Plan Area, to add a project and a project description for Lower Paia Park Parking Lot in the amount of \$300,000, and Wailuku-Kahului Community Plan Area, to add projects and project descriptions for War Memorial Gym Building Improvements in the amount of \$2,000,000, and War Memorial Stadium and Track Rehabilitation in the amount of \$1,500,000.
