name of the watershed area: My experience goes back to the late 1970's. I

was living in Keanae working taro patches maintaining the
water flume that provides water to the peninsula and patches
(lois) we farmed for a living. I've shoveled debris from
landslides, trees down, and rocks so our flume intakes could
maintain a constant level of water in the flume sufficient
for our taro patches and other farmers also. I've cutted al
ditches not only in Keanae but also Wailua where we first started
farming Kalo. The watershed area is locally known as "Chings
Pond", but the name is "Palauhulu". Altogether I've farmed
Kalo over 40 yrs. Part time rancher I raise cattle
too. Rivers in pastures have been a great tribute.

where water is being transported and ultimately used.
