TO THE URBAN DESIGN REVIEW BOARD FOR THE COUNTY OF MAUI

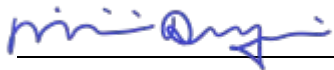
WHEREAS, by correspondence dated April 29, 2022, Mayor Michael P. Victorino notified the Council he nominated Ricky Aaron Sanches, Sr. to the Urban Design Review Board for a term expiring March 31, 2023, to fill a vacancy replacing Stuart Marlowe, in accordance with Section 2.26.030, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.

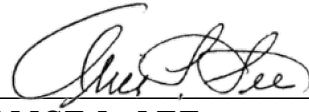
