Your Committee notes general appointment procedures for the boards are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"), and Chapter 2.41, Maui County Code ("MCC").

The following general appointment procedures apply to the various boards for which the Mayor submitted nominations.

The Mayor is required to submit nominees 60 to 70 days before the prior members' terms expire, and the Council must approve or disapprove the nominees within 60 days thereafter. If the Council fails to approve or disapprove any of the Mayor's nominees within the time period provided, the nominee shall be deemed appointed to fill the vacancy upon its occurrence. If the Council disapproves a nominee, it shall immediately notify the Mayor of its action.

Accordingly, the Council has until March 28, 2016, to approve or disapprove the Mayor's nominees, or the nominees shall be deemed appointed.

Your Committee did not request to interview any of the nominees as part of its consideration of the following boards: Affirmative Action Advisory Council, Board of Ethics, Board of Variances and Appeals, Civil Service Commission, Council on Aging, Lanai Planning Commission, Liquor Control Adjudication Board, Liquor Control Commission, Maui County Cultural Resources Commission, Maui Planning Commission, Public Works Commission, and Salary Commission. Consideration of nominees to other boards was deferred by your Committee.

Your Committee was satisfied with the nominees' applications and expressed its gratitude to the nominees for volunteering to serve the community.




