

A BILL FOR AN ORDINANCE AMENDING
THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI
AS IT PERTAINS TO ESTIMATED REVENUES;
DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, SEWER
KIHEI NO. 16 PUMP STATION REHABILITATION AND
FORCE MAIN REPLACEMENT, LAHAINA WASTEWATER
PUMP STATION NO. 3 MODIFICATIONS;
TOTAL CAPITAL IMPROVEMENT PROJECT APPROPRIATIONS; AND
TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4334, Bill No. 62 (2016), Draft 1, as amended, "Fiscal Year 2017 Budget", is hereby amended as it pertains to Section 2, Estimated Revenues, by increasing Other Intergovernmental in the amount of \$1,010,000; increasing Carryover/Savings from the Sewer Fund in the amount of \$110,000; and by increasing Total Estimated Revenues in the amount of \$1,120,000, to read as follows:

Fiscal Year 2017 Budget is hereby amended as it pertains to Section 4.A., Department of Environmental Management, by adding an appropriation for a capital project entitled, "Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement", under the Kihei-Makena Community Plan Area, Sewer, State Revolving Loan Fund, in the amount of \$1,010,000; and adding an appropriation for a capital project entitled, "Lahaina Wastewater Pump Station No. 3 Modifications", under the West Maui Community Plan Area, Sewer, Sewer Fund, in the amount of \$110,000, to read as follows:
