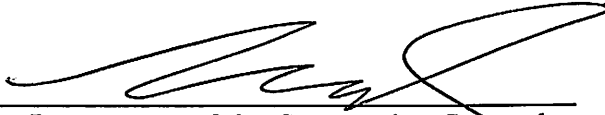
WHEREAS, in no way shall this resolution reflect on the job performance of the staff of the Office of Council Service; now, therefore,

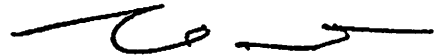
