We all know how fierce the sun can be on our skin. We use umbrellas while sitting in bleachers to watch a short 2 hour baseball, football, or soccer game. We protect our skin with SPF 50 sunscreen while sitting under an umbrella/tent when we go to the beach. We wear sunglasses to protect our eyes when we step out of our homes to do our daily errands. We would never let our children bake in the sun til they are nauseous, skin burnt and dehydrated, so why would we let any other living being be put in such an abusive and painful situation every day for 12 hours plus?

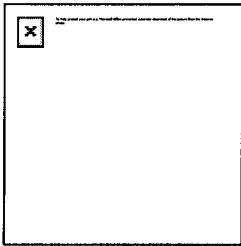

Good afternoon, Committee Chair Council Member Stacy Crivello, and Members of the Housing, Human Services, and Transportation Committee. My name is William Jacintho, President of the Maui Cattlemen's Association, testifying on HHT-43.

The Maui Cattlemen's Association would like to thank you for working on the Animal Control Law, and due to high public opposition regarding the language proposed, would **ask that this bill be deferred and discussed further with all affiliated parties.**

A few years ago, a rancher approached the Maui Cattlemen's Association regarding a violation letter he received on October 24, 2014, of Title 6 – Animals, Chapter 6.04 Animal Control. The violation cited was, "Humane manner"

- 3. Access to a barn, dog house, or other suitable shelter sufficient to protect the animal from wind, rain, and sun, said shelter shall ensure the animals health and well-being;
- 4. The shelter shall contain adequate bedding to protect the animal from wet and dampness;

Also included in the Notice of Non-Compliance Letter (attached), was a statement on the bottom of the first page, "Natural shade is not suitable shelter under this code"

As a result, we had a meeting with the Maui Humane Society, requesting clarification on the purpose and intent of the language in the law. In the discussion, it was determined that in regards to cattle, natural habitat was considered suitable shelter. Item 4, regarding keeping bedding from wet and dampness would be unachievable in natural habitat, but would pertain to a stall or barn situation. With that, MCA requested some clarification addressing this condition. At that time, Don Guzman was Chair of the Agriculture Committee, and worked on language that would address this clarification. Time went on, and we needed to revisit where we left off, and MCA had another good meeting with the Maui Humane Society on May 23, 2017. By the time the work was moving forward, Council Member Guzman was no longer the Ag Committee Chair, and the Committee went to Council Member Sugimura. An exemption was introduced, and here we are today realizing that this is not acceptable. MCA will continue to work with MHS seeking a common ground that works for both parties and the animals. MCA does not support cruelty to animals, nor do we want to interfere in the work of the Maui Humane Society. We've been working with the Humane Society, and would like to continue to work with them in good faith and good animal husbandry practices.

Here's suggested language underlined, in regards to the efforts of clarification of suitable shelter and wet and damp bedding:

3. Access to a barn, dog house, or other suitable shelter such as natural habitat sufficient to protect the animals from wind, rain and sun, said shelter shall ensure the animals health and well-being;

4. Under barn and dog house conditions, the shelter shall contain adequate bedding to protect the animal from wet and dampness;

NOTICE OF NON-COMPLIANCE

Dear animal owner/caretaker,

It has been brought to the attention of the Maui Humane Enforcement Department, through the lawful complaint process, animals being housed on your property are not in compliance with Maui County Code section 6.04.040 (B). An owner of an animal shall treat the animal in a humane manner and be subject to the penalties as provided in section 6.04.110.C.

6.04.010 "Humane manner" means care sufficient to preserve the health and well-being of an animal and, except for emergencies or circumstances beyond the reasonable control of the owner, includes, but is not limited to, the following requirements:

1. Food of sufficient quantity and quality to allow for normal growth or maintenance of body weight;
2. Open or adequate access to potable water in sufficient quantity to satisfy the animal's needs;
3. Access to a barn, dog house, or other suitable shelter sufficient to protect the animal from wind, rain, and sun, said shelter shall ensure the animals health and well-being;
4. The shelter shall contain adequate bedding to protect the animal from wet and dampness;
5. Veterinary care deemed necessary by a reasonably prudent person to relieve distress from injury, neglect, and disease;
6. Adequate space for exercise necessary for the health of the animal consistent with prudent animal care practices and access to a dry place for the animal to rest;
7. If confined, confinement area kept reasonably clean and free from excess waste or other contaminants which could affect the animal's health and air temperature suitable for the animal involved.

Natural shade is not suitable shelter under this code.
