SUBJECT: CERTIFICATION OF NET TAXABLE REAL PROPERTY

I am pleased to provide the Council with the Fiscal Year 2017-2018 certification of the net taxable real property valuation for the County of Maui, in accordance with Section 3.48.135 and Section 3.48.580 of the Maui County Code.

The Fiscal Year 2017-2018 net taxable value of real property for revenue projections is \$45,964,191,550, a 3.6% increase over last year's certified value of \$44,363,536,700. The net values multiplied by the Mayor's proposed tax rates generates \$301,649,292. After deducting \$346,825 for circuit breaker and adding \$2,077,389 from minimum tax, the grand total from real property taxes will produce \$303,379,856 in revenue.

Please be advised that the attached CD containing the assessment list will also be forwarded to the County Clerk for record keeping purposes. The assessment list and the certified values will also be available to the public on the County of Maui website.
