## CONGRATULATING THE SEABURY HALL BOYS BASKETBALL TEAM FOR WINNING THE DIVISION II STATE TITLE AT THE 2025 STATE BASKETBALL CHAMPIONSHIPS

WHEREAS, the Seabury Hall boys basketball team won the 2025 Division II State title at the Hawai'i High School Athletic Association's State Basketball Championships, February 19-21, 2025, in Honolulu, Hawai'i; and

WHEREAS, Seabury Hall's route to the State championship included a quarterfinal victory over Kaiser on February 19, 2025, and a semifinal win against Kohala on February 20, 2025, both at the Kaimuki High School Gym; and

WHEREAS, the Spartans secured their school's first boys basketball State title with a decisive 49-33 victory over Hawai'i Preparatory Academy at Stan Sheriff Center on February 21, 2025; and

WHEREAS, standout performances in the championship game included Bromo Dorn's 20 points, seven rebounds, two assists, and three steals, with no turnovers, and Sebastian Peterson's 17 points—along with seven rebounds, three assists, and two steals—including several clutch free throws to seal the win; and

WHEREAS, Bromo Dorn was voted by the media and HHSAA as the Most Outstanding Player, and Sebastian Peterson was selected to the All-Tournament Team;

WHEREAS, the team achieved a record-breaking 30-win season, the most in school history; and

WHEREAS, Seabury Hall's boys basketball team has demonstrated consistent improvement over recent years in State tournaments, placing fifth in 2023 and second in 2024 before winning the State championship this year; and
