A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2025  
BUDGET FOR THE COUNTY OF MAUI, DEPARTMENT OF  
MANAGEMENT, OFFICE OF RECOVERY PROGRAM;

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended, "Fiscal Year 2025 Budget", Section 3.B.11.c., Department of Management, Office of Recovery Program, is amended to add conditional language for the Council for Native Hawaiian Advancement for the Lahaina Festival in the amount of \$75,000, to read as follows:

11. Department of Management			
c. Office of Recovery Program	805,332	31,870,650	32,675,982"
(1) Disbursement for salaries and premium pay is limited to 8.0 equivalent personnel.			
(2) Up to \$100,000 must be for a contract with a Maui-based architectural firm to design and register building plans for each of the six sizes of accessory dwelling units listed under Chapter 19.35, Maui County Code.			
(3) Up to \$7,247,000 must be for wildfire-related expenditures.			
<u>(4) Up to \$75,000 must be for the Council for Native Hawaiian Advancement for the Lahaina Festival.</u>


