A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY  
CODE, ON NAMES OF PUBLIC FACILITIES DESIGNATED

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 12.40, Maui County Code, is amended by amending  
its title to read as follows:

**“Chapter 12.40**

**NAMES OF PUBLIC [FACILITIES] PLACES DESIGNATED”**

SECTION 2. Section 12.40.010, Maui County Code, is repealed.

**[“12.40.010 Names designated.** The names of public  
facilities described hereinafter are named as indicated.”]

SECTION 3. Material to be repealed is bracketed. New material is  
underscored. In printing this bill, the County Clerk need not include the  
brackets, the bracketed material, or the underscoring.

SECTION 4. This Ordinance takes effect on approval.
