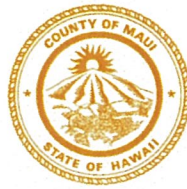

WHEREAS, by letter dated March 30, 2020, Mayor Michael P. WHEREAS, Section 13-2 of the Charter requires the Mayor's nominees to be approved by the Council; and

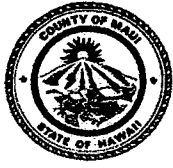
