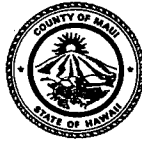

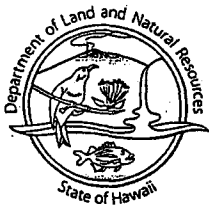

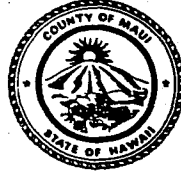

Responding to your May 10, 2004 memo regarding the above matter, please be advised that we have just issued a confidential, attorney/client memo to Deputy Director Jeff Pearson of the Department of Water Supply, requesting that his office research, review and investigate the issues, matters, concerns and allegations set forth and, to date, identified in the 1981 Quitclaim Deed from Pioneer Mill Company, Ltd. to Michel, the 1994 Agreement between the Board of Water Supply and Michel, the proposed "Assignment of Rights Under Deed" document from the State of Hawaii to the County of Maui, and Michel's April 4, 2004 letter to your office.

Due to the nature and concerns of our office regarding this situation, and in anticipation of possible litigation against the County, we cannot provide you or anyone who received a copy of your May 13, 2004 memo, a copy of our memo to Mr. Pearson.

Based on the results of Mr. Pearson's review and investigation, we are hopeful that the situation may be resolved. Call if further discussion is needed.

Please find attached a letter that was received in our office at the end of April from Mr. Hans Michel. According to Mr. Michel's letter, this matter has been pending for over ten years.

In a separate conversation with Mr. Michel, he knows that the Water Department has been assisting with other matters relating to his problems, however he does not want to be forced into hiring another outside attorney to handle these matters. As stated in his letter, he has already expended \$6,600 in legal bills and continues to pay taxes on what appears to be county property.

The copy of the agreement is on file at the Water Department and it would appear that the other TMK No. 4-6-17-1 also raises concerns for Mr. Michel as well as other area residents.

I would ask that you respond to this matter no later than May 20th and in the meantime based on Mr. Michel's letter, we are sending him claim forms relating to the monies he believes he is due.

AGREEMENT

THIS AGREEMENT, made and entered into this 3 day of June, 1994, by and between HANS MICHEL, whose address is 1404 Olona Place, Lahaina, Maui, Hawaii 96761-1754, referred to as the "Owner", and the BOARD OF WATER SUPPLY of the COUNTY OF MAUI, a political subdivision of the State of Hawaii, Wailuku, Maui, Hawaii, its successors and assigns, referred to as the "Board",

W I T N E S S E T H:

WHEREAS, the Owner represents that he is the fee simple owner of a parcel of real property situated at Panaewa (Kanaha Valley), Lahaina, Maui, Hawaii, identified as Tax Map Key 4-6-17:12, referred to as the "Property"; and

WHEREAS, the Board operates and maintains the Kanaha Pump Station No. 2 located within the Property; and

WHEREAS, the Board utilizes the existing unimproved roadway located on the Property to access the Board's 0.30 MG Kanaha Tank, and the Kanaha Pump Stations No. 1 and No. 2; and

WHEREAS, the Board desires to obtain from the Owner title to the Kanaha Pump Station No. 2 site and easements for waterlines and access; and

WHEREAS, the Owner had made a request to the Board to provide compensation, improvements, water service, and

pursue a resolution with the State of Hawaii on the maintenance of the roadway and stream crossing located within the State of Hawaii property identified as Tax Map Key 4-6-18:7. The Board shall limit its maintenance work to repair damage or wear caused by the Board with crushed rock waste or base coarse. Damage to the stream crossing due to storm generated stream flows shall be jointly funded by the Owner and Board.

3. Drainage Control Improvements Within the Board's 0.30 MG Kanaha Tank Site:

The Board shall repair damages to the roadway adjacent to the southern boundary of the 0.30 MG Kanaha tank site, referred to as the "Tank Site", caused by rainfall surface runoff flowing through the Tank Site. Repair work shall restore the surface of the ground to their original condition to the extent that such restoration work is reasonably possible.

4. Board Vehicles Parking on the Property Adjacent to the 0.30 MG Kanaha Tank:

The Owner shall allow Board vehicles to park on the Property on the southern side adjacent to the Tank Site. The Board shall provide grading work to maintain the parking area.

8. Repair Eroded Areas Within the Property and Along the Pedestrian Trail:

The Board shall discuss with the State of Hawaii and Pioneer Mill Co., Ltd. the request by the Owner to repair the pedestrian trail along the cliff that was eroded by the overflow water from the screenbox and also the erosion on the Property caused from the overflow water.

9. Boulder Removal:

The Board shall, at its own cost, remove the five boulders from the Property. The Owner may choose to have the Board relocate the boulders to a different location within the Property.

10. Relocation of Board Waterlines:

The Board shall, at its own cost, relocate a portion of the six-inch waterline from Pump Station No. 2 into the access easement area (onto the existing roadway area).

11. Ownership of the Pump Site No. 2:

The Owner shall grant, convey and dedicate unto the Board title to the Kanaha Pump Site No. 2 site, as revised. The Board shall transfer the title for the Kanaha Pump Station No. 2 site back to the Owner or his heirs in the event the pump station function is abandoned by the Board, at no cost to the Owner or his heirs.

The Board shall not give permission to anyone to use the flowage easement, except its employees and agents who are pursuing business of the Board.

15. Payment of Attorney Fees:

The Board shall pay the Owner for his attorney expenses in the sum of NINE HUNDRED AND NO/100 DOLLARS (\$900.00) incurred during the May 11, 1993 meeting.

16. Reimbursement to the Owner for Improvements Performed by the Owner Which Benefitted the Board:

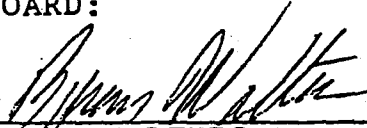
The Board shall pay FORTY THOUSAND AND NO/100 DOLLARS (\$40,000.00) to the Owner for the materials, equipment and labor the Owner had expended for various maintenance and improvements performed which benefits the Board.

The locations of the subjects within paragraphs 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14 and 16 are shown on the map attached hereto as Exhibit "A", as revised.

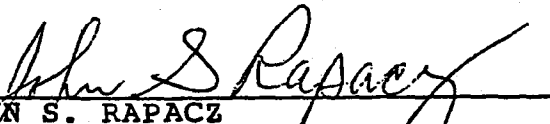
17. Damage or Injury from Landslide or Earthquake and Falling Rocks:

The Owner shall not be responsible or liable for any damage to property or vehicles or injuries to person caused by landslide or earthquake and rocks from the hillside. Board shall indemnify and protect Owner from any and all claims for damage to Board's property or vehicle or injury to its employees resulting from such landslide, earthquake or falling rocks, including attorney's fees and costs.

Dear Mr. & Ms. Michel,

We are writing to request a Right of Entry through your property located at TMK 4-6-17:001, to repair landslide damage to the Kanaha Stream intake. This will give us permission to travel across your property to get to the intake and make the necessary repairs.

This intake is the major municipal drinking water source for the town of Lahaina. It was destroyed by a landslide in May of 1992. Under emergency provisions, the Department of Water Supply has maintained municipal supply with temporary measures since that time. The stream bed has now had time to stabilize, making the repair possible.

The Kanaha intake was first built in 1904, and moved to its current elevation in 1908. It has been serving water to Lahainaluna School and to Pioneer Mill since that time. The County obtained interest in this intake in 1909. Although several repairs have been made during the 90 year existence of the Kanaha Stream intake, we have been unable to locate formal Rights of Entry for your property or your share of a property at TMK 4-6-17:001. We must traverse this property in order to reach the intake. This is a matter of public necessity.

Our request to traverse your property to repair this crucial municipal supply does not in any way constitute an intention on our part to infringe with your kuleana water rights.

We feel it would be more beneficial to all involved to formalize rights of entry, for the purposes of repairing and maintaining the intake. We do not require a permanent easement through your property, only permission to access our intake when necessary for repairs and maintenance. However, we would be willing to survey and delineate an easement if you should so desire.

Please advise us at your earliest convenience as any difficulties you foresee in granting us the Right of Entry. Thank you for your cooperation.

We apologize for this damage, and have contacted DLNR regarding possible mitigative measures. We are writing to request permission to bring the DLNR staff archaeologist on to your land for the purpose of data recovery on these damaged lo'i walls.

Repair of Damages

Thank you for the opportunity to comment on the damages at the Hans Michel property, and the Council's proposed \$150,000 claim to initiate repairs. The department relies on access through the Michel property to access the Kanaha Valley Intake, Wells and Tank for maintenance and operation.

During heavy rains, landslides in the valley above the intake sometimes occur. This blocks the intake, restricts water from reaching the Lahaina Water Treatment Plant, and requires a large excavator to walk up the valley to clear the intake. We experienced this condition a couple years ago.

Mr. Michel identifies two areas of concern: (1) A stream ford used to access the Michael property was damaged when the excavator walked across it, and (2) a dry stack rock retaining wall constructed by Mr. Michel was damaged when the excavator traveled too close to the wall.

The department is reviewing remedies, however, due to limited funds are not able to finance these remedies. Thank you for the Council's assistance to fund these remedies. Please contact us if you have any questions or require further clarification.
