Chair and Members:

Your Policy, Economic Development, and Agriculture Committee, having met on February 12, 2018, makes reference to County Communication 17-7, from Council Chair Mike White, relating to nominations to boards, committees, and commissions.

By correspondence dated and received on January 30, 2018, the Mayor transmitted a proposed resolution, entitled "APPOINTMENT OF A MEMBER TO THE HANA ADVISORY COMMITTEE FOR THE COUNTY OF MAUI," along with a completed application for the nominee. The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of Lipoa Kahaleuahi (Designated Native Hawaiian Traditional and Customary Practices Expert) to the Hana Advisory Committee for a term beginning on April 1, 2018, and expiring on March 31, 2023.

Your Committee notes general appointment procedures for boards and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code ("MCC").

Your Committee further notes specific provisions for the Hana Advisory Committee are located in Sections 2.28.060, 2.28.070, and 2.40.130, MCC.

The Council must approve or disapprove Ms. Kahaleuahi's nomination to the Hana Advisory Committee by March 31, 2018, or the nomination will be deemed approved.

Your Committee did not request to interview the nominee.

A representative of the Mayor said Ms. Kahaleuahi is a resident of Hana and currently employed at Ma Ka Hana Ka 'Ike as a Community Outreach Coordinator. She is a board member of Hana Arts and is a hula student of Halau O Nakaulakuhikuhi. She was also a teacher at Kulia I Ka Pono Kamehameha Schools Enrichment Program in Hana during the summers of 2013, 2014, and 2017.

Your Committee noted this is the first vacancy on the Hana Advisory Committee since Ordinance 4431 (2017) was enacted. Ordinance 4431 (2017) required the Maui, Molokai, and Lanai planning commissions and the Hana Advisory Committee to each have at least one member with demonstrated expertise in Native Hawaiian traditional and customary practices. Ms. Kahaleuahi's background and cultural experience meet the requirement to be designated the cultural expert for the Hana Advisory Committee.

Your Committee felt the nominee would be a good representative for the Hana community.

Your Committee voted 7-0 to recommend approval of the nomination of Lipoa Kahaleuahi to the Hana Advisory Committee, and that Exhibit "B" to the proposed resolution be revised accordingly. Committee Chair Sugimura, Vice-Chair Crivello, and members Atay, Carroll, Cochran, Hokama, and White voted "aye." Committee members Guzman and King were excused.

Your Committee is in receipt of a revised proposed resolution, approved as to form and legality by the Department of the Corporation Counsel, incorporating your Committee's recommended revision.
