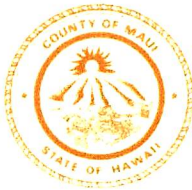

SUBJECT: A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE U.S. DEPARTMENT OF ARMY, CORPS OF ENGINEERS RELATED TO THE DESIGN OF THE WAILUKU RIVER FLOOD CONTROL IMPROVEMENT PROJECT

The attached bill for an ordinance authorizes the Mayor to enter into an intergovernmental agreement with the U.S. Department of Army, Corps of Engineers (USACE), to complete the design of a federal undertaking at the Wailuku River Flood Control Project.

The project will involve removal of an existing revetment along the stream, installing a pre-formed scour hole, and implementing a flood warning system. These improvements will allow for greater energy dissipation and decrease scour along the levee system. The project is also anticipated to reduce maintenance costs and improve resiliency of the flood control system.
