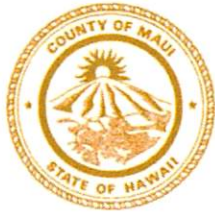


WHEREAS, Chapter 13.04A, Maui County Code, authorizes the Council to accept gifts and donations on behalf of the County; now, therefore,
