Chair and Members:

Your Parks, Recreation, Energy, and Legal Affairs Committee, having met on September 5, 2017, September 19, 2017, and October 31, 2017, makes reference to County Communication 17-6, from Council Chair Mike White, relating to litigation matters.

By correspondence dated August 21, 2017, the Department of the Corporation Counsel requested consideration of the possible settlement of Claim 30177967397-0001. Attached to the request is a proposed resolution, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 30177967397-0001 OF THE HERTZ CORPORATION," and a copy of the claim and related documents. The purpose of the proposed resolution is to authorize the Department to settle the claim for \$19,823.10.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

According to the proposed resolution, the claim against the County arose from damages caused when a Department of Liquor Control employee operating a County vehicle collided into a vehicle owned by The Hertz Corporation in Wailuku, Maui, Hawaii, on March 10, 2017.

A Deputy Corporation Counsel provided a brief overview of the case. She said the incident occurred when the employee of the Department of Liquor Control was driving on Honoapiilani Highway in the Waikapu area, got distracted, and rear-ended the vehicle in front of him. She said four vehicles were involved in the incident, including the County's vehicle. The

claim before your Committee involves property damage to The Hertz Corporation's vehicle only. Property damage claims involving the other two vehicles were resolved within the Department of the Corporation Counsel's discretionary authority.

Your Committee asked about the Department's policy concerning employees involved in driver-related incidents like this one.

The Deputy said after the incident, the Department was provided a refresher class on defensive driving.

Your Committee voted 5-0 to recommend adoption of the proposed resolution to authorize settlement of the claim. Committee Chair Guzman and members Atay, Carroll, Crivello, and Hokama voted "aye." Committee Vice-Chair King and members Cochran, Sugimura, and White were excused.

Your Parks, Recreation, Energy, and Legal Affairs Committee RECOMMENDS that Resolution \_\_\_\_\_\_, attached hereto, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 30177967397-0001 OF THE HERTZ CORPORATION," be ADOPTED.
