SECTION 1. Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended "Fiscal Year 2025 Budget", Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for Fiscal Year 2025, Immigrant Services Division United States Passport Application Acceptance Facility Revolving Fund, is amended to add conditional language authorizing the use of the fund for operations and services in the amount of \$17,500, to read as follows:


