A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.76, MAUI COUNTY CODE, RELATING TO ADMINISTRATIVE RULES FOR THE MOLOKAI FARMING COST REIMBURSEMENT PROGRAM FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 3.76.040, Maui County Code, is amended by amending Subsection (D) to read as follows:

“D. The [mayor or mayor's designee,] director of agriculture, in consultation with the state department of agriculture, must adopt administrative rules necessary to carry out the purposes of Act 387, session laws of Hawaii[, ] 1988, as amended, and this chapter.”

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This Ordinance takes effect on November 15, 2023.


This bill proposes to amend Section 3.76.040, Maui County Code, relating to administrative rules for the Molokai Farming Cost Reimbursement Program Fund.
